ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 1 – Superfecta wagering on the race cancelled as the field was scratched down to five betting interests.

Race 2 – Inquiry posted on unofficial first place horse (dead heat) No. 4 ITS SWAN TIME for possible pylon violation nearing the finish. Video confirmed that the horse was inside one pylon and the judges determined that this allowed the horse to gain momentum allowing it to finish in a dead heat for the win with No. 8 ELHELPSKI. For a pylon violation allowing the horse to gain an unfair advantage No. 4 ITS SWAN TIME finished first (dead heat) placed second. Driver Jordan Ross fined \$200.00.

Race 5 – Inquiry posted on unofficial second place finisher No. 5 WATCH MISS TUCKY (Kyle Husted) for possible violation of the breaking rule right at the finish. After reviewing video and speaking with Mr. Husted (to ask if interference could have been the reason for the horse breaking stride) the judges determined the horse ran on her own, and there was no reason to place the horse back from where she finished as she was not lapped on or placed up as she was not interfered with.
