## **State Coordinator's Report**

State Coordinator Jim Corridan shared that the Research Indiana Catalog is live. Press releases were sent out Tuesday, October 3<sup>rd</sup>. IARA is continuing to work on getting the word out, and Communications Director Sam Alderfer is creating a brochure. Newman suggested sending it to all Indiana librarians, and Witcher suggested reaching out to the Indiana Genealogical Society.

Corridan said that outreach efforts have continued, with visits from Secretary of State Lawson, and several State Representatives and staff. Most recently, about 20 leaders from African American community, including Representative John Bartlett visited for a tour.

Corridan said that there is now a COSA task force to reform the relationship between NARA and state archives. Their goal to share research and make sure the entities aren't replicating efforts. These efforts may alter how SHRAB functions in some ways. Newman asked if they talked about whether SHRABs would review grants and Corridan said it was being discussed. He said that included in the draft of a report to be sent to David Ferriero, there is a recommendation to hold a meeting between this COSA task force and NARA. One of the agenda items would be the grant process. The report also calls for more money to be sent to SHRABs and a recommendation to move toward a block grant program.

#### **SHRAB 2017 Report**

Corridan said that the report will be given to the Governor's Office for feedback before being sent to the legislature. The SHRAB went through the report page by page and made several content and format changes. Corridan said that it will be sent to the Governor's Office by Wednesday, October 18<sup>th</sup>.

Motion to approve report as amended. Witcher – Newman. Motion Carried. Votes in Favor: Corridan, Krasean, Newman, Wilson, Witcher
