The Administrative Law Judge ("ALJ") in this Matter issued an Order on the Motion For Summary Judgment Granting Respondent's Motion For Summary Judgment filed with the ALJ on June 3, 2024. The Complainants, by their counsels, Spenser Benge and Clifford Robinson, and for the public interest in Complainants' complaints, Indiana Civil Rights Commission ("ICRC") Staff Attorney, Yvette C. Kirchoff, submitted Complainants' Objections to the Order on Motion For Summary Judgment on August 19, 2024. Respondent, by their counsels, Provided its Response In Opposition to the Complainants' Objections to the Order on Motion For Summary Judgment on September 25, 2024, and also submitted, by their counsels, their Response to the Complaints' Objections To the Order Granting the Motion For Summary Judgment on October 2, 2024. The objection period in this matter has closed, and with both

# sides having filed Objections in this matter, oral arguments are scheduled for today.

ii. ICRC/Darian Day v. Jerry Wenger (HOha23090705)

Submitted to the Commission October 4, 2024

The ALJ in this matter issued a non-final order that the Respondent in this matter did indeed violate the Indiana Fair Housing Act and the Indiana Civil Rights Law regarding the Complainant on the basis of discriminating against people with disabilities and regarding unlawful retaliation in the protected area of housing. The Complainant is awarded compensatory damages of nine thousand, seven hundred dollars (\$9700.00), emotional damages of twentyfive thousand dollars (\$25,000.00). The Respondent is ordered to cease and desist from discriminative acts and retaliating against people because of a protected activity. The parties in this matter came to a mediated settlement, leaving the Non-Final Order before the commission as they are required to approve any order after a hearing has been set. The objection period in this matter has closed.

iii. ICRC/Darian Day v. Jerry Wenger (HOha23090705)

Submitted to the Commission Dec. 16, 2024

The ALJ in this matter granted Complainant's Motion To Dismiss this matter as she was able to confirm that the Parties had reached a settlement and there was no evidence of any fraud, coercion, duress, or any ither reason not to grant the dismissal. **The objection period in this matter has closed.**
