i. Gerald Rowe v. The Health and Hospital Corporation of Marion County D/B/A Eskenazi Health (PAha22010026)

Submitted to the Commission June 7, 2024

The Administrative Law Judge in this matter has determined that the Complainant's Motion for Partial Summary Judgment as to liability is DENIED, that the Complainant's Motion to Strike Evidence is DENIED, and that the Respondent's Motion for Summary Judgment is GRANTED, with the Complaint of the Complainant being hereby DISMISSED with prejudice. Complainant's attorneys have filed an objection to the Summary Judgment. Respondents have filed an objection to the Complainant's objection. The objection period in this matter has closed, but with both sides having filed Objections in this matter, oral arguments will be scheduled for the September meeting.

ii. Gregory L. Wilson, Sr., in his official capacity as the Executive Director of the Indiana Civil Rights Commission v. ML Indianapolis I, LLC, and Eighteen Capital Group (HOra23100795) Submitted to the Commission July 3, 2024

The Administrative Law Judge in this matter has determined that the Notice of Election that the Respondent's counsel filed in this matter was timely and thus successful in moving this case out of the administrative forum and is DISMISSED with prejudice 910 IAC 2-7-9(a). The objection period in this matter has now closed.

iii. Gregory L. Wilson, Sr., in his official capacity as the Executive Director of the Indiana Civil Rights Commission v. ML Indianapolis I, LLC, and Eighteen Capital Group (HOra23100796) Submitted to the Commission July 3, 2024

The Administrative Law Judge in this matter has determined that the Notice of Election that the Respondent's counsel filed in this matter was timely and thus successful in moving this case out of the administrative forum and is DISMISSED with prejudice 910 IAC 2-7-9(a). The objection period in this matter has now closed.

iv. David Dominguez v. Shield Exteriors, Inc. (EMra23100772)Submitted to the Commission July 24, 2024

The Administrative Law Judge in this matter has, after having scheduled a telephonic status conference for July 16, 2024, that neither the Complainant or counsel was present for, issued a Notice of Proposed Default Order that failed to have a response filed within the seven (7) day deadline, resulting in a Default Order against the Complainant. The objection period in this matter has now closed.

The objection period in this matter has not closed and no decision on this matter is due at this time.

The Administrative Law Judge in this matter, after having considered all the evidence and testimony presented by both parties, GRANTED Respondent's Motion for Summary Judgment and DISMISSES Complainant's complaint with prejudice. The objection period in this matter has now closed.
