The Administrative Law Judge in this matter has determined that the Complainant has failed to meet their burden of proof, rules in favor of the Respondent and against the Complainant, DISMISSING their complaint with prejudice. Complainant's attorneys have filed an objection

to the Nonfinal Administrative Decision and the Respondents have filed a brief in opposition to the Complainant's objection, to which the Complainant still has time for a response. The **objection period in this matter has not closed and no decision on this matter is due at this time.**
