

Indiana Charter School Board Annual Report December 2015

This report was submitted 12/31/15 to the SBOE and IDOE in fulfillment of the requirements listed in Ind. Code §§ 20-24-9 and 20-24-3-10. It provides several key pieces of data for the ICSB and its authorized schools, including: general school information, academic and attendance data and financial audits for the 2013-2014 and 2014-2015 school years. Pursuant to statutory requirements, this report also describes those charter school operators who applied to the ICSB in the Spring and Fall application cycles and the status of those applications.

Only schools operating during the applicable school years will have academic data. Two academic years of information is provided as a result of a policy decision by ICSB staff to not allow the report to lag behind a full year in wait for A-F accountability grades. Moreover, it should be noted that the data sources utilized for information regarding the 2014-15 school year differ from the data sources utilized in the compilation of information regarding the 2013-14 school year. As a result, data may appear to be more significantly different than they otherwise would be presented. The ICSB has taken care to identify the data source for each section of the report. The data sources used regarding the 2014-2015 school year will be the sources for annual reports moving forward.
