ICSB Authorized Charter Schools: Academic Results

In 2021, the General Assembly passed HEA 1514, which: 1) Repealed all consequences (e.g., closure, state takeover, non-renewal, inability to receive choice scholarship funding) for poor performance on the State's accountability system for all traditional public, public charter, and private choice schools; 2) Directed SBOE to establish a "transparency dashboard," described as "a compilation of longitudinal data indicating school performance success in various selected and enumerated program areas"; 3) Directed SBOE to assign null or no letter grades to all schools for the 2020-21 school year. In sum, schools have been "held-harmless" for academic performance in 2014-15, 2018-19, and 2019-20, and were assigned a "null" or no letter grade for 2020-21, leaving 2017-18 as the last academic year with valid and proficiency and growth data.

SBOE has been in the process of revising its existing accountability rule since 2017 and is not likely to complete these revisions until 2022 or 2023, after the General Assembly determines if and/or how to reconcile the old accountability structure with the new "transparency dashboard," a framework for which was approved by SBOE at the December 2021 board meeting.
