Estimated Amount of One-Year Contract: \$71,621.80

The State elected to remove line item #30 from the evaluation. Therefore, no award was made for this line item only.

Bid Evaluation Summary

The solicitation was issued as a Negotiated Bid to establish a statewide Quantity Purchase Agreement.

The bids were evaluated according to the criteria established in the bid documents and their adherence to requirements. When necessary, the State clarified with Respondents to ensure specifications were met.

All responses were evaluated on price and preferences. Sirchie Acquisition Company LLC and Thomas Scientific LLC claimed the U.S. Manufactured Preference for select line items.

Award Summary

The State awarded to the overall low bidder meeting all specification requirements. Line items were awarded while bearing in mind the best interest of the State.

The final overall evaluation score is listed in the table below.

During the course of evaluation, the State scrutinized the bids to determine the viability of the proposed business solution to meet the needs of the State. IDOA evaluated the bids based on the stipulated criteria outlined in the bid documents.

Pending successful contract negotiations, the initial term of the contract shall be for a period of **one (1) year** from the date of contract execution. There may be **three (3) one-year renewals** for a total of **four (4) years** at the State's option.
