**Total Purchase Price: \$154,140.19**

Based on the evaluation of responses received for Negotiated Bid 24-78900, **Bright Equipment Corporation dba Bobcat of Columbus** is recommended for award to provide one (1) Compact Track Loader and Drum Mulcher to the Indiana Department of Natural Resources – Division of Forestry. Terms of this recommendation are included in this letter.

The evaluation team received bids from two (2) Respondents:

- Bright Equipment Corporation dba Bobcat of Columbus
- Ronson Equipment Co., LLC

The bids were evaluated according to the criteria established in the bid documents and their adherence to requirements. When necessary, the State clarified with Respondents to ensure specifications were met.

### Purchasing Preferences Claimed

- **Bright Equipment Corporation dba Bobcat of Columbus** claimed and qualified for the Buy Indiana/Indiana Business Preference (IBP).
- **Ronson Equipment Co., LLC** claimed the Buy Indiana/Indiana Business Preference (IBP), but did not qualify.

Preferences claimed were applied to the bid and were considered in the evaluation <sup>1</sup>.
