Quarterly Fact Sheet

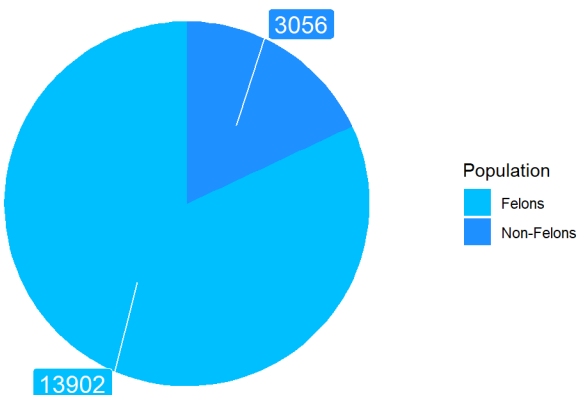

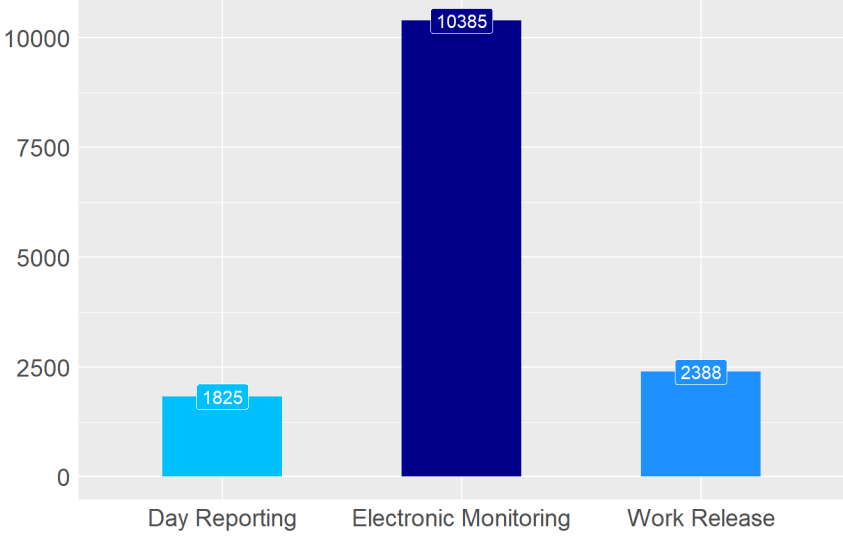

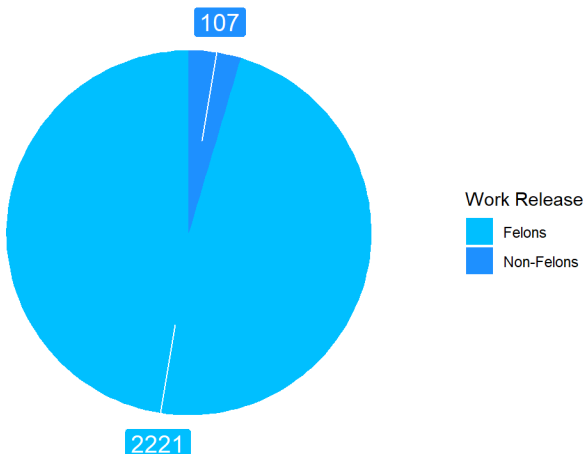
For Community Corrections Population: This is a count of the total number of individuals with an active Community Corrections Case.

For Levels of Supervision: Individuals may be on more than one Level of Supervision at a time. Due to this, some individuals may be counted under more than one category. This report shows a sum of the total number of times a Level of Supervision is utilized.

As of 2024, supporting entities (Jail Treatment, Probation, Pre-Trial, and Prosecutor’s Diversion) are only required to report the number of individuals served based on grant funding requests for the calendar year.

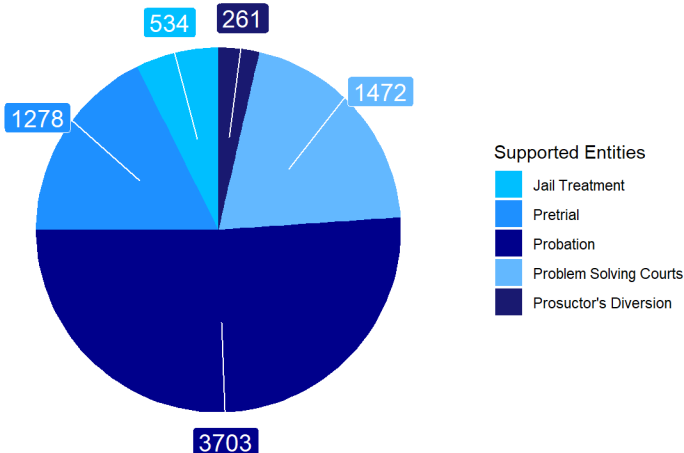
