Dear Judge Heath:

As required by 210 IAC 6, an inspection of the juvenile detention standards was conducted on August 28, 2013 at the Allen County Juvenile Detention Center. Detention Inspectors from the Indiana Department of Correction conducting the inspection were Vanessa Krause, Shannon Bowling and Jan Adams.

The Allen County Juvenile Detention is operated by the Allen County Superior Court and is located at 2929 Wells Street, Fort Wayne Indiana. The facility was built in 2004 and accommodates 142 juveniles. Jamie Mann is the Facility Superintendent.

This inspection constitutes the seventeenth annual inspection of the Allen County Juvenile Detention Center. 100% compliance with all mandatory standards and at least 90% of the recommended standards is required to attain "Full Compliance".

The inspection included a review of all mandatory and recommended standards, a tour of the facility, and detention staff and residents were interviewed. Juveniles offered no instances of abuse and no complaints about conditions were noted. Staff were well versed in policy and procedure and offered support for administration.

Summary of Tour:

- Facility was very clean and well organized.
- Facility kitchen was clean, organized.
- Many programs are available to students.

- Much improvement from previous inspection.
