Mr. Hunter,

An annual inspection of juvenile detention centers, for compliance with Indiana standards is required annually pursuant to 210 IAC 6. The 2013 inspection constitutes the 3rd annual inspection of Cedarbridge, and the 15<sup>th</sup> inspection of the facility located at 901 West Riggin Road, Muncie, Indiana. Compliance with all mandatory standards and at least 90% of the recommended standards is required to attain "Full Compliance" in accordance with the aforementioned code. The inspection was completed by Vanessa Krause, Jan Adams, and Kellie Whitcomb: Indiana Department of Correction Juvenile Detention Center Inspectors.

IDOC continued to provide technical assistance as facility staff made improvements and developed action plans to address non-compliant standards since the inspection last year. This inspection included a tour of the facility, a review of all mandatory standards and non-mandatory standards, and interviews with the staff and students. There were no complaints from the students of any kind of mistreatment and the staff interviewed was very knowledgeable of policy and procedure and positive in regards to administration.

**Summary of Tour:**

The facility was clean and in good repair. Improvements to the physical plant are ongoing.

**Summary of Folders:**

Folders were well organized and easy to review. Director Barr discussed the possibility of creating electronic inspection files in the near future.

**Summary of Audit:**

The Center was found to be in compliance with 100% of Mandatory folders and 97.4% on all non-mandatory folders. A certificate of "Full Compliance" will be issued. The staff at Cedarbridge have demonstrated a professional and caring attitude, and have made significant improvements to the operation of the facility over the past year.
