As of February 2022, the Community Corrections population reflects the number of active individuals by their county of commitment on the last Tuesday of the month. This population includes all pre & post convictions and excludes Community Transition Program (CTP) and Juveniles.
- (2) Community Corrections data for county of commitment as of 10/01/2022.
- (3) Local Jail Holds as of 10/01/2022.
- (4) As of January 1, 2021, all Marion County Community Corrections Pretrial participants were transferred to Marion County Probation for supervision, resulting in a significant decrease in the total population.
- (5) As of January 2022, all Community Corrections data is self-reported and uniformly collected under the Supervised Release System (SRS). Community Corrections population may be supervised by other county agencies than their county of commitment. Community Corrections agencies may also administer or oversee additional types of services, treatments, or grant programs as part of the Community Corrections & Justice Reinvestment Grants (i.e., Probation, Pretrial Services, Court Recidivism Reduction Programs, Prosecutor's Diversion, and Jail Treatment programs) that are not reflected in this data as of 1/1/2020.
