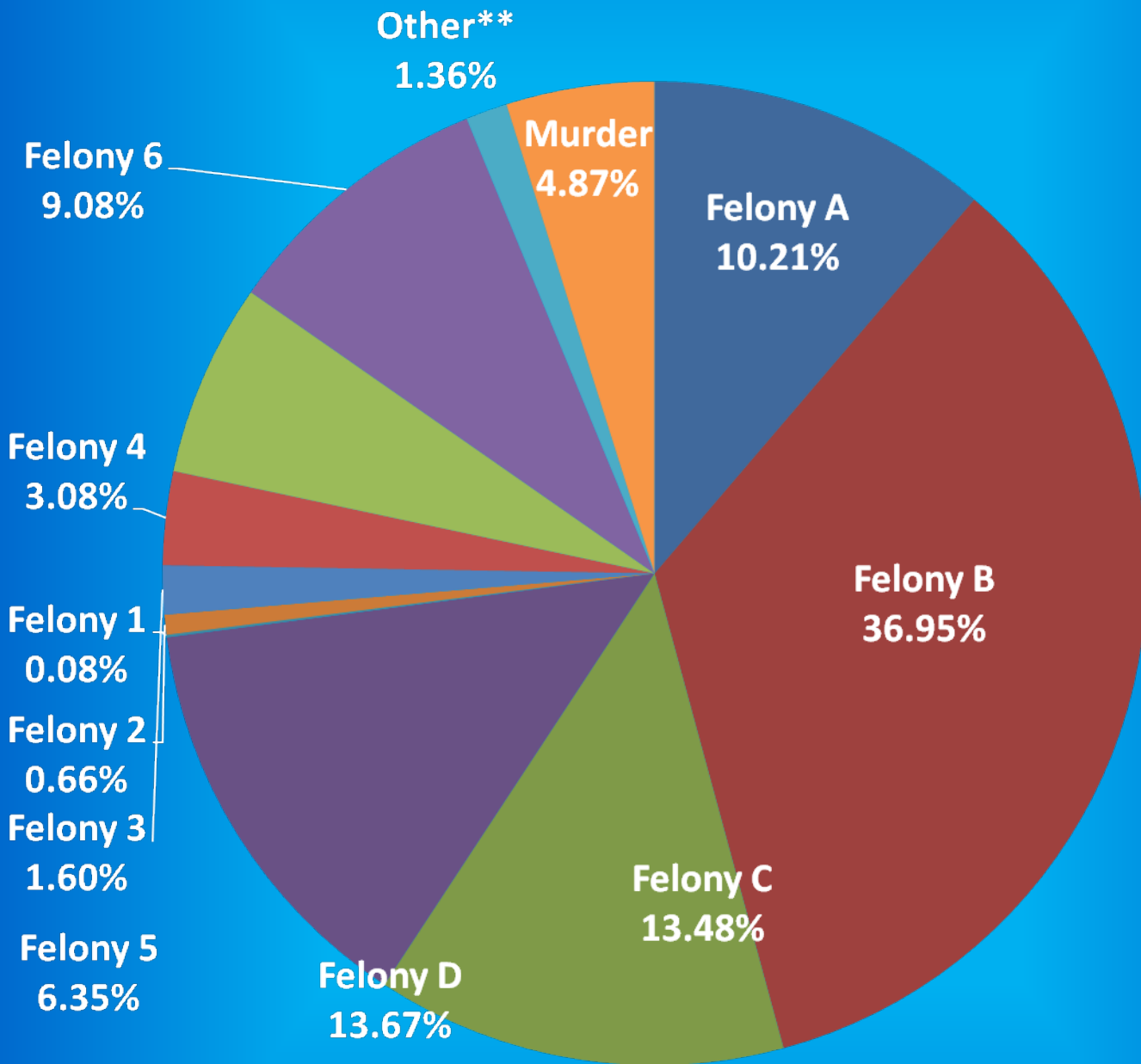

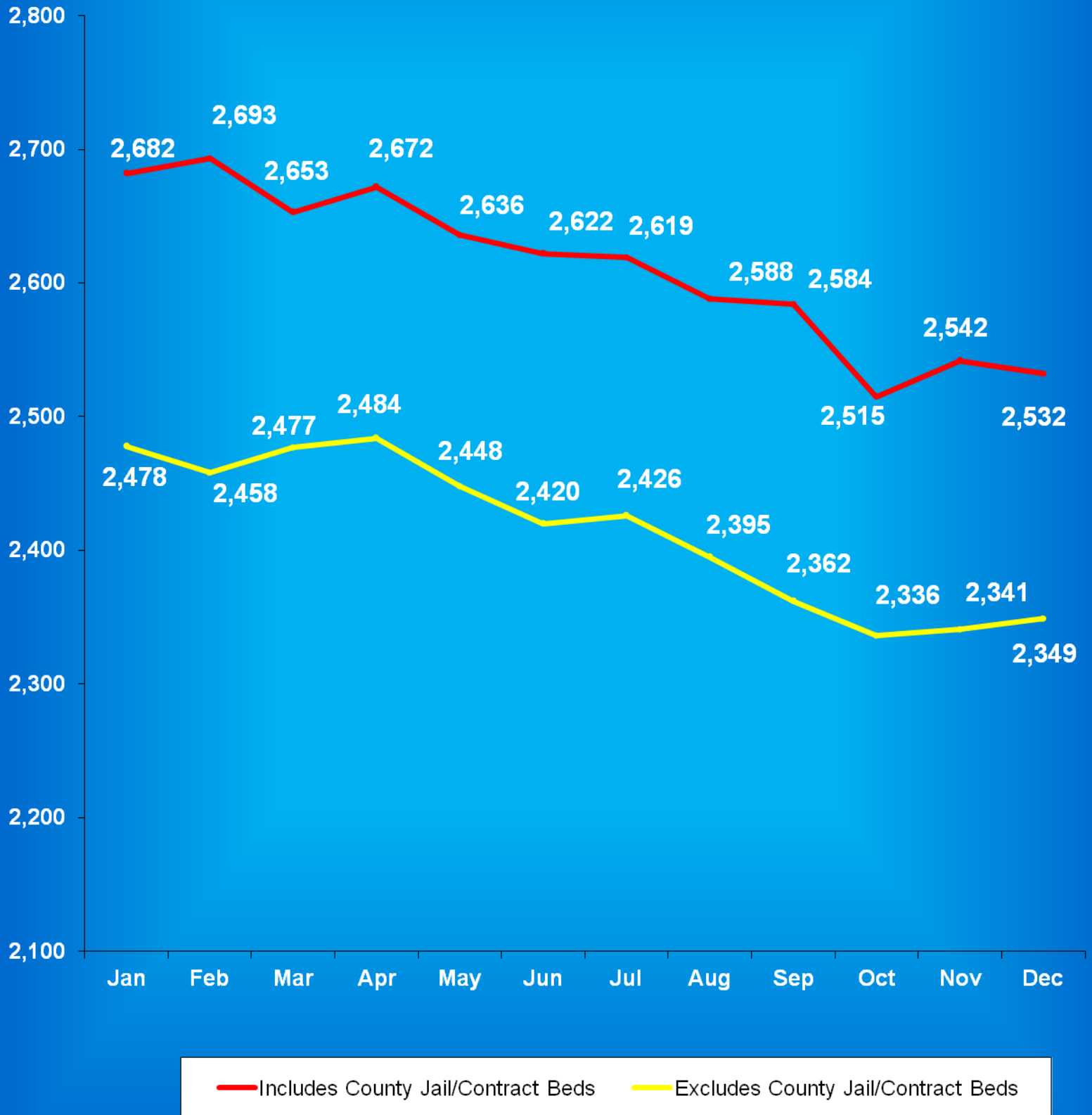

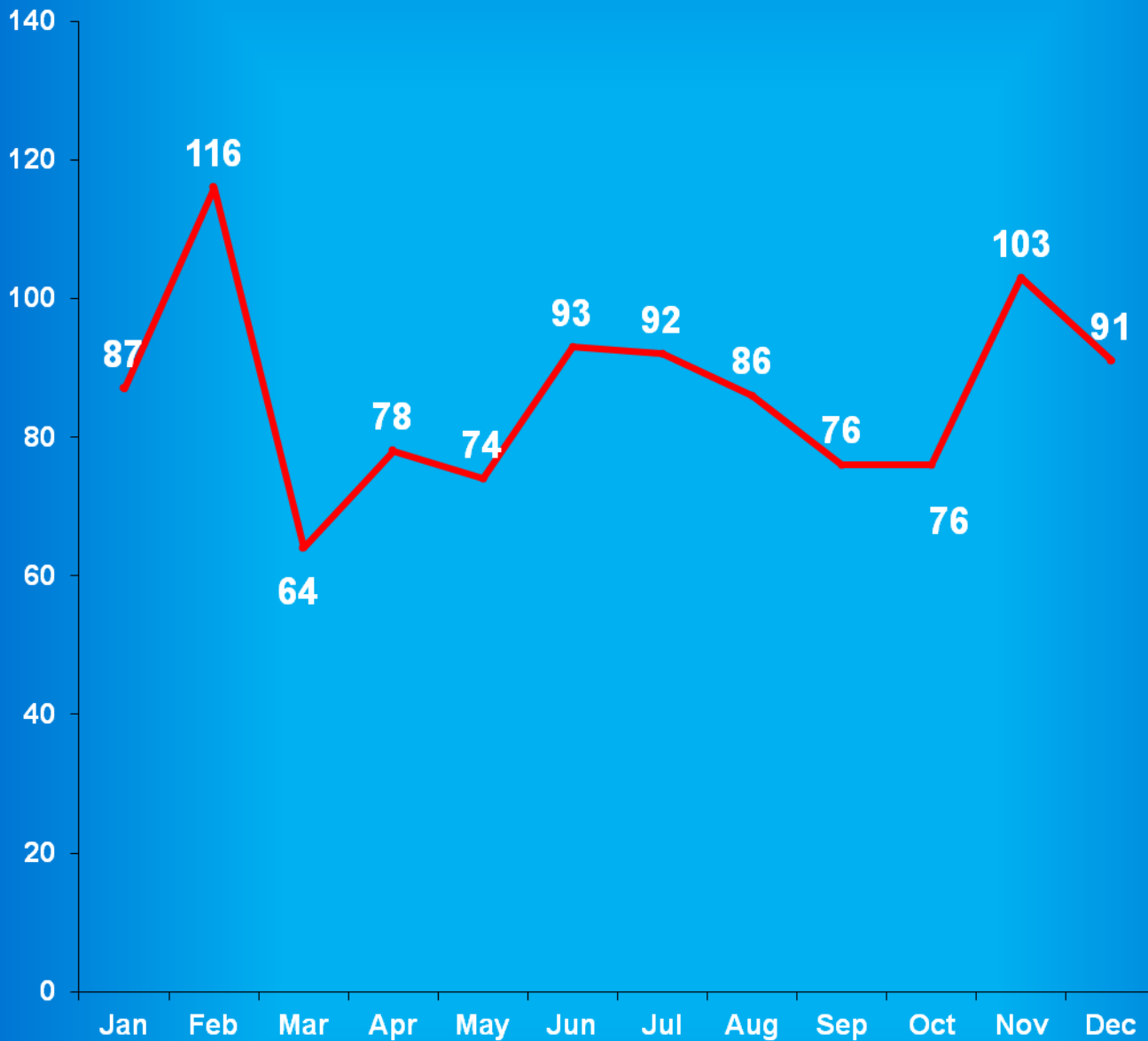
### Average Daily Adult Female Offender Populations Calendar Year 2015

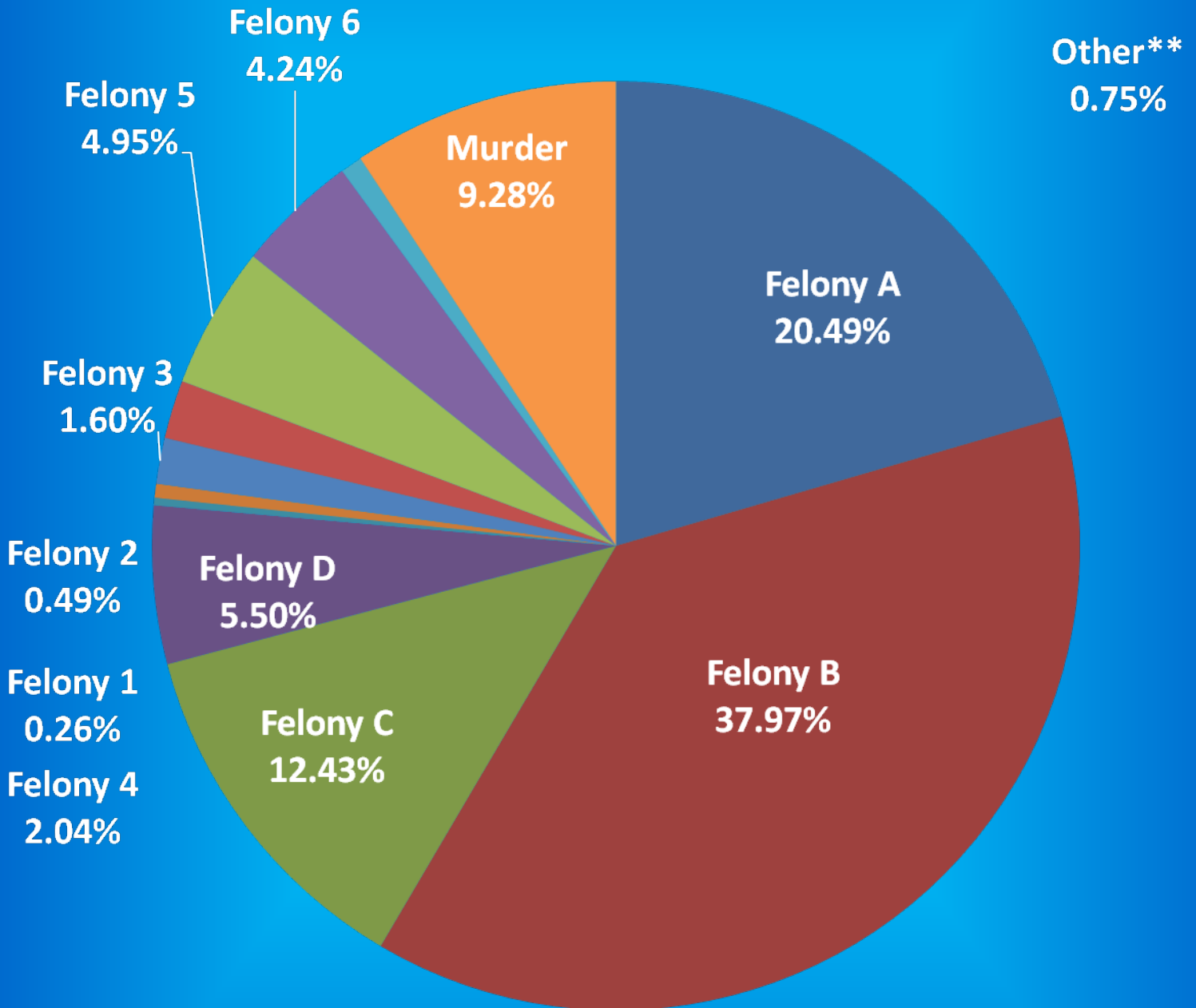

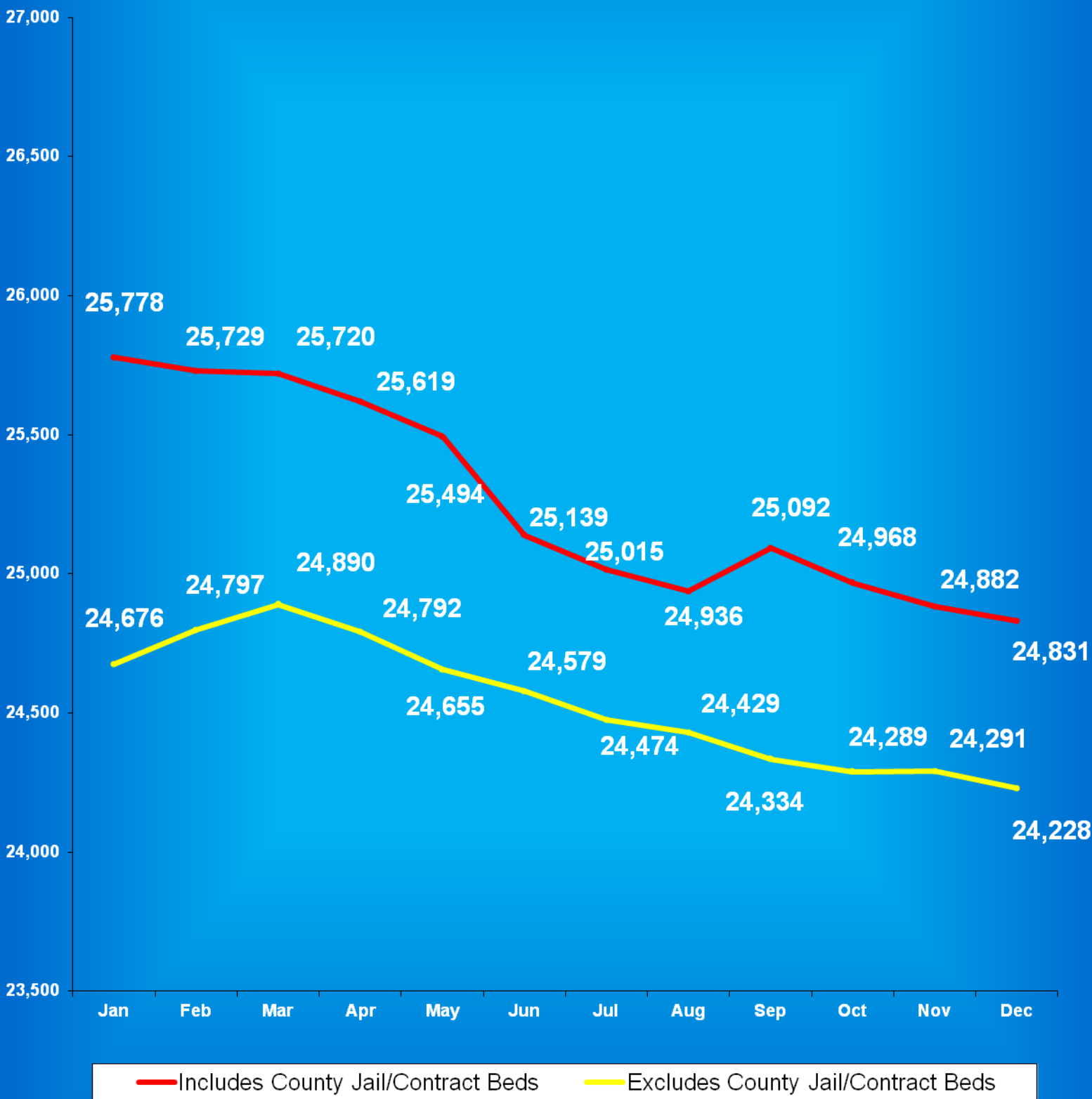

### Average Daily Adult Male Offender Populations

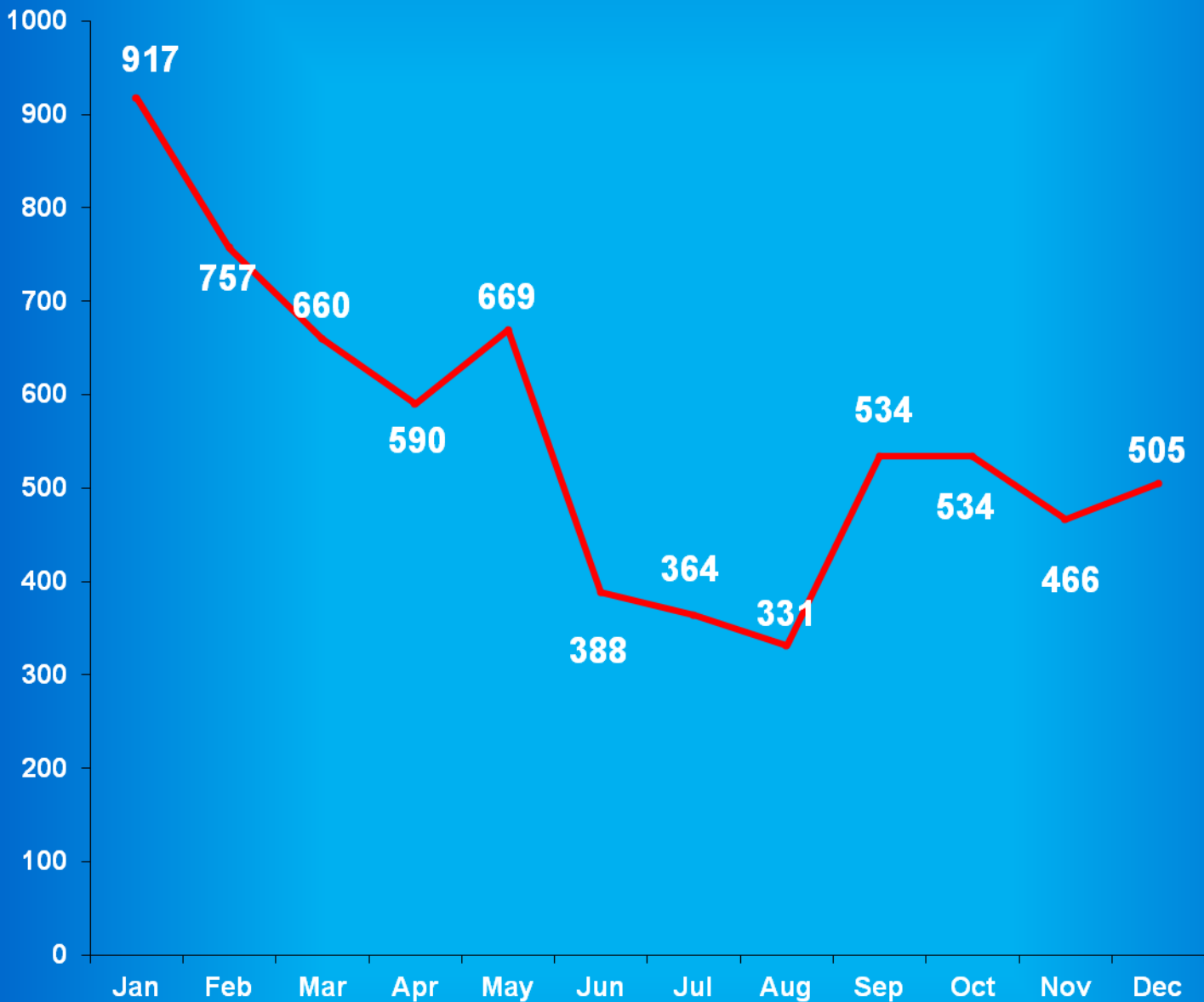

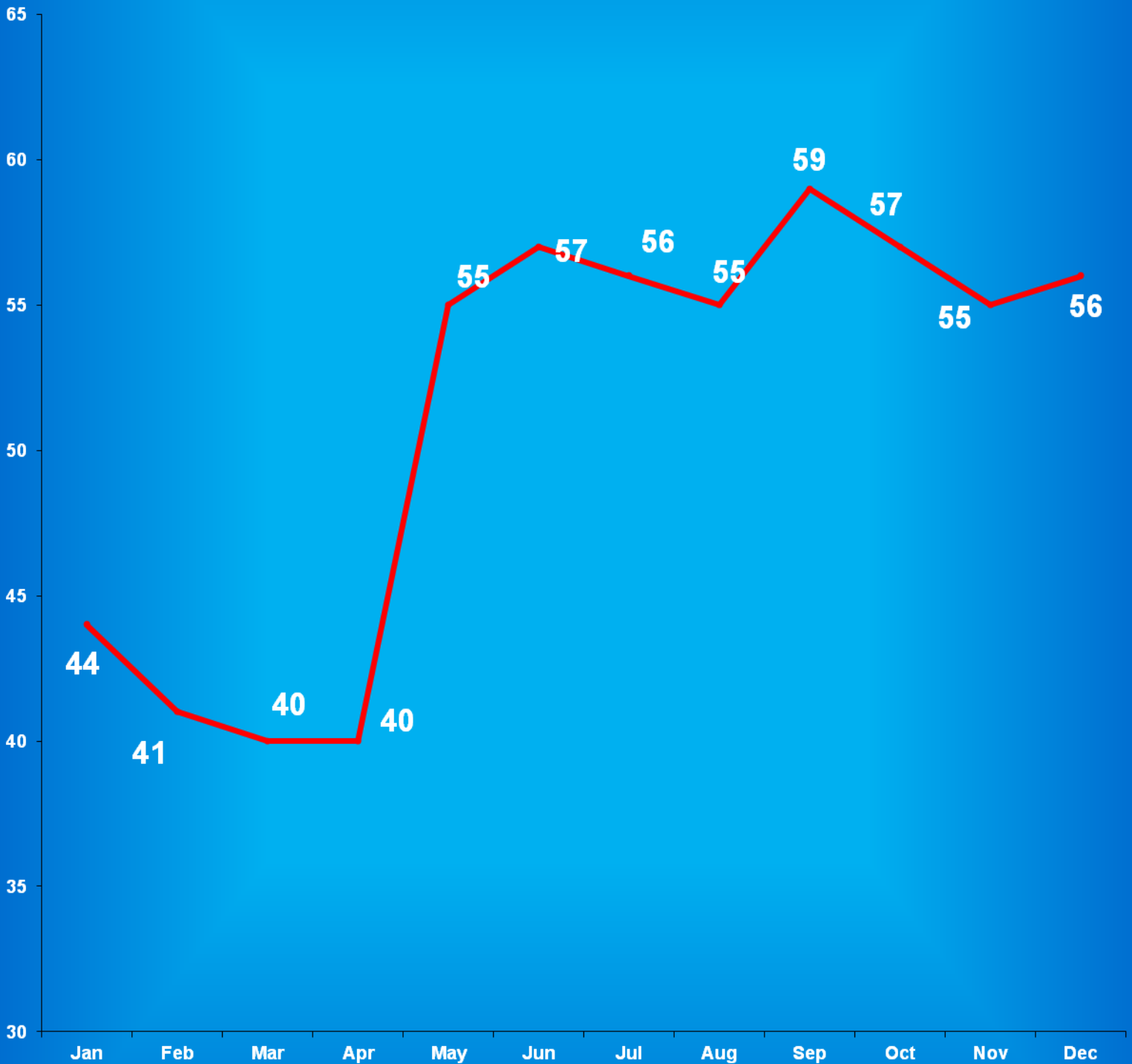

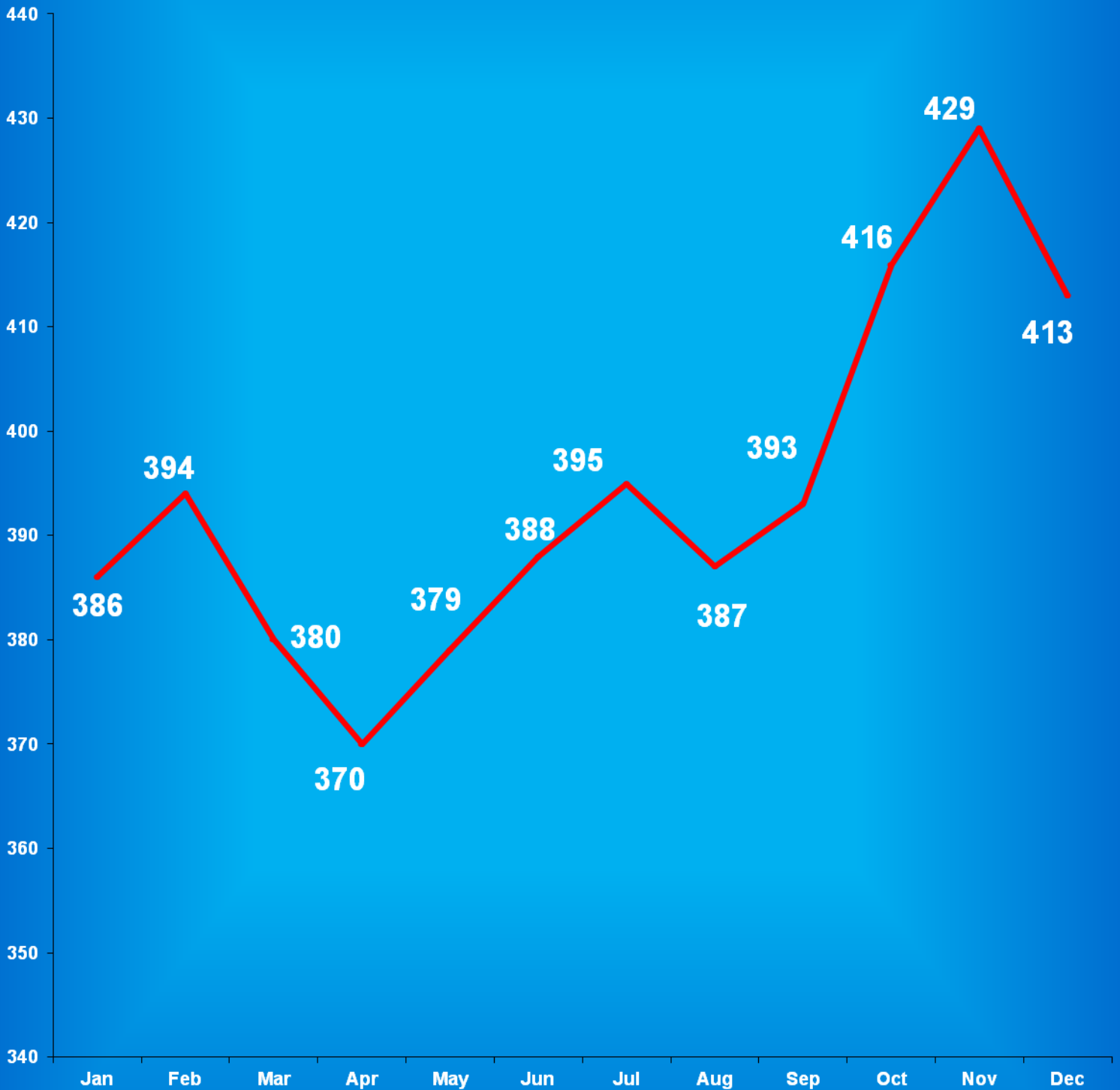
