- (4) As of January 1, 2021, all Marion County Community Corrections Pretrial participants were transferred to Marion County Probation for supervision, resulting in a significant decrease in the total population. As of January 1, 2023 Pretrial participants were transferred back to Marion County Community Corrections for supervision, resulting in a significant increase in the total population.
- (5) As of January 2022, all Community Corrections data is self-reported and uniformly collected under the Supervised Release System (SRS). Community Corrections population may be supervised by other county agencies than their county of commitment. Community Corrections agencies may also administer or oversee additional types of services, treatments, or grant programs as part of the Community Corrections & Justice Reinvestment Grants (i.e., Probation, Pretrial Services, Court Recidivism Reduction Programs, Prosecutor's Diversion, and Jail Treatment programs) that are not reflected in this data as of 1/1/2020.
