#### What do I need to know this month?

- · Change Agent Network Updates:
  - · Change Agents received communication materials and reminders including:
    - Presentation materials for speaking on this Quarter's Facility Recall (or similar meeting). Your facility's Change Agent Lead should have already requested permission to speak at it. If not, please reach out to them. The Change Agent List can be found here.
    - DELTA vs. TOMS one page document to share with peers that showcases the difference between where we were with TOMS and where we are with DELTA.
    - A request to record an Experiential Video that includes all the Change Agents at a facility speaking about DELTA. The video will be uploaded onto the DELTA Stream site.
- What's In It For Me DELTA One Pagers are live on the DELTA Intranet. These documents
  have been created for each module to highlight what's new, what's the same and some of the
  primary roles that will be using each of the modules within the DELTA system.
- **DELTA training** began for all staff across 6 regional training locations on January 3rd.
  - Pursuant to Executive Directive 22-54 shared in November 2022, all staff are required to complete and/or attend training on the new DELTA system.

- Pilot Testing Preparation: Pilot testing is where staff at select facilities will complete their daily
  tasks in both the DELTA system and the legacy systems, that will ultimately be replaced, to
  make sure everything is working properly. They will report any issues or bugs they find. Pilot
  testing will begin in mid-February and take place at the following facilities / parole districts:
  - Rockville South Bend Re-entry Center, Wabash Valley, Logansport Juvenile, and Madison Parole District).

- Continue to ask your facility or parole district's Change Agents for a demonstration of the **DELTA System** and hear what they explored with this month's Scavenger Hunt.
