Project Wins and Activities

The project continues to anticipate a 2023 go-live. Below are some of the most recent 'wins' and upcoming activities:

Recent Project "Wins":

- Began discussing the Warrants, Scheduling, and Count modules with IDOC SMEs and the Mi-Case business analysts (BAs)
- Released new functionality into the DELTA system in Sprints 12 and 13 for the following modules: Classification, Conduct, Detainers, Movement, Parole, PREA, Sentencing, Intake, and Case Management
- Resumed GAP/FIT analysis for identifying gaps of functionality in the DELTA system for the Purposeful Incarceration module
- Held a Sprint UAT Refresher meeting for DOC testers
- Offender files were migrated into the DELTA system with our 4th iteration of data migration

Upcoming Activities:

- Begin configuring the DELTA Banner for Parole and configuring the Visitation module
- Review reports that will not be produced within the DELTA system with the Change Board in order to receive their approval on the future state of these reports


