Pilot

Through our agile development approach, DELTA undergoes continuous testing by IDOC staff. In February, prior to Go-Live, a new type of testing will take place - Pilot Testing. During Pilot Testing, a select group of facilities will *pilot* the system by completing dual-entry activities (in both the current systems & in DELTA) to verify accuracy of data & functionality.



What's In It For Me?

What's In It For Me Delta one-pagers are individual documents, *by DELTA Module*, designed to highlight important information related to each module including:

- What IDOC activities or processes are completed in that specific Module and the key benefits that the DELTA System brings
- What changes are coming to each specific Module with the new DELTA system
