## Key Definition:



### Birthright Access

Birthright access is a term that refers to the system access that is given to all staff, *at an individual level*, for Go-live. It is based on your current role and the responsibilities you complete, thus allowing you to continue to do so when DELTA launches.

Following the launch of DELTA, you can request additional access by submitting a request to the DOC help desk.

Additional information regarding this process will be shared at go-live. Please note: Requests for additional access will be reviewed by the DELTA project team and may require staff to complete additional trainings.



## Experience Lab

DELTA Experience Labs offer the opportunity for staff to request temporary access to the DELTA system in order to further explore & become comfortable with system functionality. The objective is to provide people with the

### Pilot is March 27<sup>th</sup> – March 31<sup>st</sup>

All staff at Central Office, Rockville, South Bend, Wabash Valley, Logansport Juvenile, and Madison Parole District will participate in Pilot. Pilot is the last phase of testing that the DELTA system will undergo before its launch in April. During Pilot, staff at the locations listed above will complete their daily tasks in both legacy systems & DELTA. This helps the project team test the system and business processes mimicking day-to-day operations.

Specific information and resources for completing Pilot will be shared directly with staff who are participating. In addition, participants will receive an invite to a kickoff session where the DELTA Project Team will further address expectations and requirements.
