Each month we will **highlight the positive impacts** the DELTA system will bring to each module and in turn the benefits that staff will experience when using it.

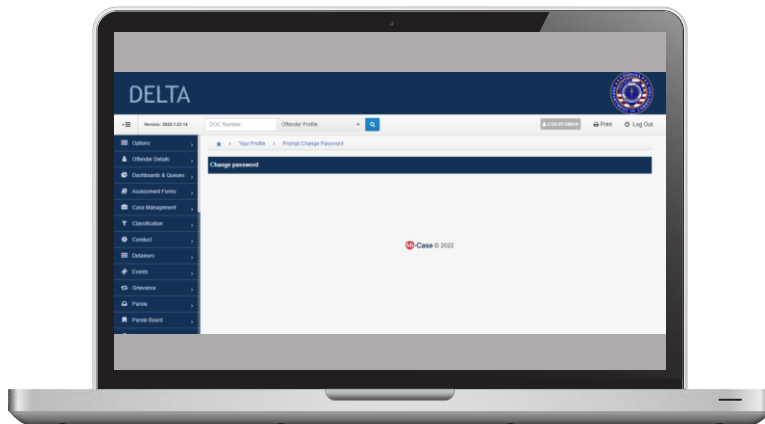

What benefits is DELTA bringing in the Visitation Module?



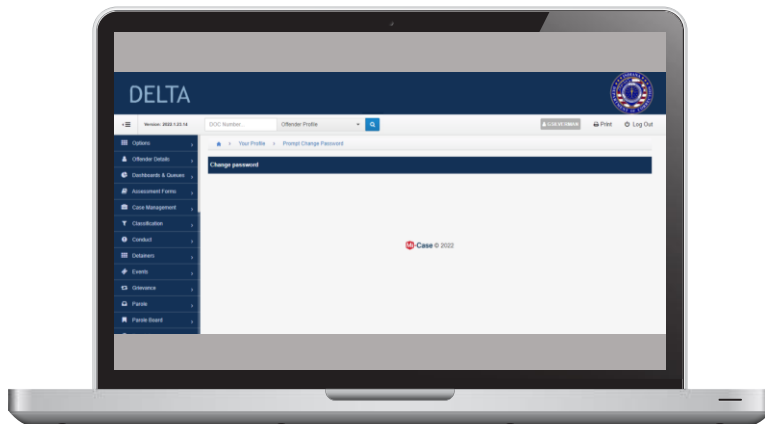
The Visit Registration Screen is an **all-in-one place** to view the visitor list, visiting privileges, suspension reasons, and whether visitors have been denied multiple times.

Visitation Officers **will have access to computers** with DELTA and will be able to retrieve all necessary information.

What benefits is DELTA bringing in the Visitation Module?



DELTA will **include emergency visits** as a special visit type and will track approvals within the system.

The Visitation Administration screen will show a **history of visitors who have been removed** from visiting privileges and who removed them.

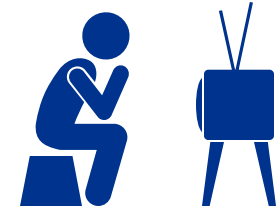
