NOTICE OF AMENDMENT TO FORM A FILING**

This notice is being provided in connection with the proposed acquisition of control of **ONENATION INSURANCE COMPANY**, an Indiana domiciled insurance company and wholly owned subsidiary of **ATH HOLDING COMPANY, LLC**, an Indiana limited liability company which, in turn, is a wholly owned subsidiary of **ANTHEM, INC.**, an Indiana corporation, by **FHP INSURANCE HOLDING CO.**, a Delaware corporation and a wholly owned subsidiary of **FRESENIUS HEALTH PARTNERS, INC.**, a Delaware corporation, which is a wholly owned subsidiary of **FRESENIUS MEDICAL CARE HOLDINGS, INC.**, a New York corporation (together, the "ACQUIRING PARTIES").

On April 29, 2015, the **ACQUIRING PARTIES** filed Amendment No. 1 to their Form A Statement regarding the proposed acquisition of control of **ONENATION INSURANCE COMPANY** that was originally filed on January 16, 2015.
