Terms	Definitions	
80-Day	80-Day New Data Implementation Period refers to the 80 calendar days allotted to Health Payers, per Indiana Rule, to submit newly required data after receipt of the approved and final publication of the updated Data Submission Guide.	
Claims Data:	Describes Insurance claims that contain Eligibility, Provider, Medical and Pharmacy data.	
Encrypted Test File:	A sample test file that is submitted by payers to ensure that their registration & SFTP process are successfully established.	
Historical Year Data:	Data that spans the date of January 2023 – December 2024. This data is to match up with what is being requested from CMS and Medicaid.	
Monthly Data Files:	Similar to historical data files, this is Eligibility, Provider, Medical and Pharmacy claims data, but on a monthly basis.	
New Data:	HEA 1004 Commissions/Brokerage Fees, found in Indiana Code IC 27-1-15.6-13.5, refers to the inclusion of any commission, service fee, or brokerage fee that has been or will be paid to an insurance producer for selling, soliciting, or negotiating the policy or contract; and (2) whether the amount disclosed under subdivision (1) is based on a percentage of total plan premiums, or a flat per member fee	
Previous Year Data:	Data that spans the date of January 2024 – December 2025. This data is to match up with what is being requested from CMS and Medicaid.	
Reporting	The time period for dates-of-services on claims that are being submitted to the APCD.	
Period:	Example: August 01 - August 31 dates of service.	
SFTP:	Secure File Transfer Protocol	
	The primary means by which Onpoint is going to receive claims data from the submitters.
