Any transactions submitted during this period will be declined until Gateway processing resumes on Tuesday, May 16th, 2017.

Effective May 16th, 2017 Indiana will add and update various retaliatory fees for the non-resident licensing applications. The new and updated fees are separated by transaction type and license class.
