THE MAY 16, 2013 HEARING WILL BE RESCHEDULED TO A DATE TO BE DETERMINED PRESS RELEASE FOR UNFAIR PRACTICE COMPLAINT

Noblesville Teachers Forum, et al., have filed a complaint against the Noblesville Schools, Board of School Trustees alleging that the School Corporation committed an unfair labor practice. The case before the Indiana Education Employment Relations Board (IEERB) has been assigned Case No. U-12-03-3070.

The hearing in this case is scheduled for Thursday, May 16, 2013, commencing at 9:00 a.m. EDT, at the Conference Room, 100 North Senate Avenue, Room N1045, Indianapolis, Indiana. The Hearing Examiner who will preside at the hearing is **Stephen L. Lucas**.

Sometimes it becomes necessary to continue a case to a later date or the scheduled hearing does not occur because the case is settled by the parties. It is a good idea to check with the parties or the IEERB before attending a hearing to determine if the scheduled hearing will actually take place.

IEERB was established by statute in 1973 to promote harmonious and cooperative relationships between public school teachers and the school corporations they serve, thereby improving education for all Hoosier children. Among IEERB's major functions are conciliation and mediation, fact finding, research, unit determination and representation, and unfair labor practice adjudication.
