Brief Description of Item Solicited, Accepted, or Received and approximate value of item:

Agency leadership requested Doug Harter serve as the lead for Indiana's state team at the Midwestern Higher Education Compact (MHEC) Midwestern Dual Enrollment State Policy Workshop on July 29th and 30th, 2025, at the Big Ten Conference Center in Rosemont, IL (Chicago). This workshop convened state teams from across twelve MHEC member states to network, share learning and best practices, and develop action plans to improve dual enrollment policies. Participants assessed their state's policy strengths and gaps, exchanged insights with peers from other states, and developed actionable state-specific strategies to improve identified weaknesses. Mr. Harter assembled a team of seven others from Indiana, consisting of representatives from state educational agencies and higher education institutions. In his role at the Indiana Commission for Higher Education, Mr. Harter oversees all aspects of dual credit/enrollment and transfer credit for the state of Indiana, and thus, why he was asked to attend the workshop and serve as the lead for the state team.

All expenses for the workshop, including registration, travel, food, and lodging were covered by MHEC. Some of these expenses, such as registration, parking, dinner and breakfast at the workshop, and lodging, were not charged to the participant. Other expenses, such as mileage, lunch to/from the workshop, and tolls were reimbursed to the participant. The approximate value of these covered expenses is: \$578 (dinner and breakfast at the workshop, lodging, mileage, lunch to/from the workshop, and tolls).
