Re: Waiver of Application of 42 IAC 1-5-1 (the "Gift Rule") for Certain Items of Value Received INDOT Employees in Relation to the 2025 Asphalt Pavement Association of Indiana Winter Conference in Muncie, Indiana on December 11 & 12, 2025.

Chairwoman Noel:

Commissioner Lyndsay Quist, the appointing authority to the Indiana State Department of Transportation, ("INDOT"), has designated authority to me as the agency's ethics officer to waive application of the Gift Rule in individual cases when consistent with the public interest. I am hereby waiving application of 42 IAC 1-5-1 (a) for items of value that will be received by INDOT ninety-four (94) INDOT employees, see **Exhibit A**, attached that was held on December 11 &12, 2025. Each employee will benefit professionally from attendance for the reasons provided below.

The APAI Winter Conference will be held at the Muncie Horizon Convention Center, 401 South High Street, Muncie, Indiana 47305, on December 11 & 12, 2025. INDOT employees will be able to hear speakers with subject matter expertise and connect with APAI members, local government representatives, consultants, contractors, and subject matter experts to discuss, learn, and engage with one another. The APAI provides complementary registration to INDOT Employees, the registration fee is four hundred twenty-five dollars (\$425) per employee, for a total of thirty-nine thousand nine hundred fifty dollars (\$39,950,) for ninety-four (94) employees. The registration fee includes lunch on December 11, 2025.

The complementary registration is being provided by the Asphalt Pavement Association of Indiana (APAI), an organization whose members include asphalt contractors, suppliers, engineering consultants, and service providers. Through its committees and staff, APAI works in close partnership with INDOT and with many of Indiana's cities, towns, and counties. APAI members include INDOT vendors and suppliers with ongoing business relationships with the Department. APAI itself is an industry partner of the Department with an interest in the business and operation decision-making of the agency. Corporate trinkets potentially made available to attending INDOT employees may potentially be offered by existing Department vendors or companies with an interest in future agency contracting opportunities. While such souvenirs are not subject to the prohibition on excepting gifts under 42 IAC 1-5-1, receipt is being disclosed in the interest of complete transparency.

INDOT personnel covered by this waiver were instructed not to accept any other item of value from any other person or entity if that person or entity may have a business relationship with INDOT or may seek to influence an action by one or more INDOT personnel in his or her official capacity. INDOT personnel are regularly

The APAI is primarily educational in nature, and the INDOT employees listed in **Exhibit A** will be attending, as well as participating in marketing, engineering and transportation forums. Employees will be able to take advantage of the unique opportunity to engage diverse industry stakeholders and experts on topics of particular interest to their duties at the Department.

The individuals who will attend the event are all employed in the INDOT Materials and Test, Construction, Asset Management, and Design Divisions, and therefore administer INDOT's adherence to the industry best practices in the field of asphalt paving, construction, and design. Materials and Test employees work closely with pavement industry stakeholders, such as APAI, which is the preeminent socio-educational platform for advancing asphalt paving, construction, and design. The professional services provided by these INDOT employees on behalf of the State of the Indiana are greatly enhanced through learning about evolving best practices and technological developments in asphalt construction, design, paving, engineering, and maintenance, and from exchanging ideas with commercial stakeholders at events such as product presentations, which promises to allow attendees to "explore cutting-edge technologies, gain insights from expert-led educational sessions, and build valuable relationships during several networking opportunities." Accordingly, every INDOT employee who participates in the 2025 APAI Winter Conference holds a position with duties that will directly benefit each person from their individual attendance at the event, both through the educational and networking components.

Indiana Code 8-23-2-4.1(4)(A) provides that INDOT is responsible for the "construction, reconstruction, improvement, maintenance, and repair of (state) highways" and Indiana Code 8-23-2-5(a)(4) imposes upon INDOT the statutory duty to "evaluate and utilize whatever possible improved transportation facility maintenance and construction techniques." By attending the 2025 APAI Winter Conference, INDOT employees will be educated concerning production, advanced production, and quality while engaging with industry stakeholders to ensure that they are provided with information vital to their decision making process.

Therefore, it is my opinion that is consistent with the public interest for the INDOT personnel listed in **Exhibit A** to attend the Asphalt Paving Association of Indiana 2025 Winter Conference, and to receive the items of value specified above, even though payment for these items was made by the American Concrete Pipe Association, an industry association with an interest in INDOT business, comprised of member companies including current Department vendors and firms with a potential interest in establishing a business relationship with the agency. Based on this finding, I am hereby waiving application of 42 IAC 1-5-1 (a) to allow all INDOT employees, listed in **EXHIBIT A**, to accept the complementary registration to attend the 2025 APAI Winter Conference, which the registration fee amount for all ninety-four (94) employees have a total combined value of approximately Thirty Nine Thousand Nine Hundred Fifty Dollars (\$39,950).
