#### IC 4-2-6-11

Post-Employment Waiver: Joan Sporny

As the Appointing Authority of the Indiana Department of Workforce Development (DWD), I am filing this waiver of the application of a certain post-employment restriction of the Code of Ethics as it may apply to Joan Sporny, a former Employer Auditor with DWD, in her desired post-employment with Del Principe and Allie CPAs PC (Del Principe and Allie).

I understand I must file and present this waiver to the State Ethics Commission at its next meeting on October 9, 2025. I further understand this waiver is not final until approved by the State Ethics Commission.

A. This waiver is provided pursuant to IC 4-2-6-11(g) and specifically waives the application of:

IC 4-2-6-11(b): The 365 day required "cooling off" period before receiving compensation from an employer for which the former state employee or special state appointee made a directly applicable regulatory or licensing decision.

- B. IC 4-2-6-11(g)(2) requires that an agency's appointing authority, when authorizing a waiver of the application of the post-employment restrictions in IC 4-2-6-11(b)-(c), also include specific information supporting such authorization. Please provide the requested information in the following five (5) sections to fulfill this requirement.
- 1. Please explain whether the employee's prior job duties involved substantial decision-making authority over policies, rules, or contracts:

Ms. Sporny was an Employer Auditor with DWD. She conducted audits of employers throughout the state of Indiana to ensure their compliance with the state laws under Indiana Code 22, Article 4 (Unemployment Compensation System). Ms. Sporny did not engage in decision-making authority over policies, rules, or contracts. Nor did she choose which Indiana employers would be audited. Ms. Sporny would regularly conduct 7 to 9 audits per month and have roughly 20-25 open audits at one time. Audits could take a month or longer to complete; during that time, Ms. Sporny would compare reported figures between the employer's records and DWD's records. Upon completion of the audit, Ms. Sporny would issue findings to the employer explaining any deficiencies. If an employer did not agree with the findings, the employer could appeal; if an employer appealed, Ms. Sporny would be available to serve as a witness for DWD.



During Ms. Sporny's employment with DWD, she worked on an audit of Del Principe and Allie for approximately one month, including an in-person visit to one of their offices to review records. Ms. Sporny also worked with one of Del Principe and Allie's clients the previous year. On January 31, 2025, Ms. Sporny issued a determination resulting in financial impact on Del Principe and Allie.

2. Please describe the nature of the duties to be performed by the employee for the prospective employer:

Ms. Sporny was laid off during DWD's July 2025 Reduction in Force. She has applied for a data entry job at Del Principe and Allie CPAs. The job would consist of entering and verifying data from clients' information, invoices, receipts, and other financial documents that relate to the firm's clients' finances and taxes.

3. Please explain whether the prospective employment is likely to involve substantial contact with the employee's former agency and the extent to which any such contact is likely to involve matters where the agency has the discretion to make decisions based on the work product of the employee:

It is possible DWD could audit one of the firm's clients, in which case the firm could serve as representative for that client or the firm could be audited by DWD. As a data entry clerk, Ms. Sporny would have little involvement in matters other than collecting the information. She would not engage with the DWD auditor in a representative capacity.

4. Please explain whether the prospective employment may be beneficial to the state or the public, specifically stating how the intended employment is consistent with the public interest:

Ms. Sporny worked for Indiana as a public servant for over 40 years. Ms. Sporny developed important skills and gained valuable experience during her time in public service. The public will continue to benefit from Ms. Sporny's expertise if she begins employment with Del Principe and Allie. It is in the State's interest to allow its employees to accept employment outside the public sector, and allowing Ms. Sporny to accept the role described above is consistent with the public interest.

5. Please explain the extent of economic hardship to the employee if the request for a waiver is denied:

Not providing this waiver could lead to economic hardship for Ms. Sporny. Since being laid off in July, Ms. Sporny has worked part-time and is interested in pursuing full-time employment in the private sector.

As the Appointing Authority of the Indiana Department of Transportation (INDOT), I am filing this waiver of the application of the Code of Ethics post-employment restriction as it applies to Gary Kreutzjans ("Kreutzjans") in his post-employment with American Structurepoint ("Structurepoint").

I understand I must file and present this waiver to the State Ethics Commission at its next available meeting. I further understand that this waiver is not final until approved by the State Ethics Commission.

# 1. Please explain whether the employee's prior job duties involved substantial decision-making authority over policies, rules, or contracts:

Kreutzjans currently serves as the Construction Director at the INDOT Seymour District. Kreutzjans oversees the administration of construction contracts and projects for the Seymour District, supervises the district's Area Engineers and field staff working on INDOT construction contracts and maintains final change order signature authority up to \$750,000.

Kreutzjans has had limited interaction with Structurepoint while at INDOT. As the Construction Director, he estimates that he might have interacted with Structurepoint once or twice a quarter at larger meetings. Most decisions regarding consultants, such as Structurepoint, are addressed by the INDOT District's Area Engineers. The Area Engineers, rather than Kreutzjans make the assignments to the contracts that vendors, including Structurepoint, would oversee. As Construction Director, he would step in only when the consultant and Area Engineer could not resolve an issue. Kreutzjans does not recall when he last stepped in, if ever, on a Structurepoint issue.

Additionally, Kreutzjans filed a notice of potential conflict and screening document regarding Structurepoint on June 23, 2025, which has prohibited any contact or review of Structurepoint's consulting work and from scoring Letters of Interest (LOIs) from consultants seeking work with the Seymour District. LOI scoring does not award any contract, it only reviews to ensure applicants are qualified to do the work they are bidding on.

#### 2. Please describe the nature of the duties to be performed by the employee for the prospective employer:

In his post-INDOT employment, Kreutzjans will serve as a project engineer for Structurepoint, a firm that does business with INDOT. As a project engineer, he will be responsible for on-site work on the project level. Kreutzjans' will work on projects with INDOT and local public agencies (local governments). His name would be listed on Letters of Interest as a potential project supervisor when Structurepoint submits bids for construction inspection work on INDOT projects.

Kreutzjans will not be involved in the contracting process for projects involving INDOT or any other agency. His involvement on any project, INDOT funded or local agency-funded transportation projects, would begin after Structurepoint is selected as a firm to provide construction inspection services for a specific project.

INDOT relies on the private engineering and construction industry to design and build the state's transportation infrastructure. Structurepoint is a significant player in the field of transportation engineering in the state of Indiana and is involved in many transportation projects throughout the state, those funded through INDOT and those funded with local dollars. In his new role, Kreutzjans will be reviewing INDOT's construction vendor's work, not Structurepoint's work, to ensure compliance with INDOT specifications

3. Please explain whether the prospective employment is likely to involve substantial contact with the employee's former agency and the extent to which any such contact is possible to include matters where the agency has the discretion to make decisions based on the work of the employee:

Structurepoint currently has at least 135 open contracts with INDOT state-wide. Kreutzjans anticipates that in his new position he will have contact with INDOT personnel but he expects that his interaction will be similar to the contact of other project engineers without an INDOT background.

For projects involving federal funding, either through INDOT or the LPA program, there is INDOT oversight by the Area Engineers in the district construction department. The Area Engineers review work such as change orders that consultants, including Kreutzjans, submit. Again, the work Kreutzjans will be doing for American Structurepoint is inspecting non-American Structurepoint construction and reporting those results to INDOT for review by the INDOT Area Engineers.

Kreutzjans and Structurepoint understand that he cannot work on any project for Structurepoint that he participated in while at INDOT. His INDOT work for Structurepoint on pending projects will be limited to projects outside the Seymour District and will not begin work on projects in the Seymour District until new projects are awarded after his departure from INDOT.

4. Please explain whether the prospective employment may be beneficial to the state or the public, explicitly stating how the intended employment is consistent with the public interest:

Mr. Kreutzjans has 21.5 years of experience in the transportation engineering field, all with INDOT. Mr. Kreutzjans' knowledge and expertise in the transportation engineering and construction field would be beneficial to the public because he has a thorough knowledge of what INDOT expects in its construction projects and how to efficiently provide that quality of work. His knowledge will ensure INDOT's vision and priorities will continue to be implemented by its private sector partners.

5. Please explain the extent of economic hardship to the employee if the request for a waiver is denied:

Within INDOT, there are few opportunities for advancement of position and salary for Mr. Kreutzjans. Short of joining the executive team, there is no other higher or relevant position for Mr. Kreutzjans at INDOT. His experience is in the transportation engineering industry and it is government that builds roads with the assistance of the private sector. Denying the post-employment waiver would require Mr. Kreutzjans to either remain at INDOT or enter a new field of engineering.

WHEREAS, Gary Kreutzjans would like to discuss employment with American Structurepoint ("American"); and WHEREAS, American has a business relationship with INDOT, including active contracts; and

WHEREAS, as Construction Director for INDOT Seymour District, it is possible that Gary Kreutzjans could be assigned to participate in matters in which American has an interest as part of his regular duties; and

WHEREAS, Gary Kreutzjans's employment negotiations with American could create a potential decision and voting conflict of interest under IC 4-2-6-9 requiring disclosure and a formal screen; and

- 3. Gary Kreutzjans shall not assist any future employers, including American, with any matter he personally and substantially participated in while employed by INDOT. This restriction applies in perpetuity, for the life of the particular matter.
- 4. Pursuant to his duty under Ind. Code §5-14-3-10, Gary Kreutzjans shall not disclose or otherwise rely upon information classified as confidential under Ind. Code §5-14-3-4. This restriction applies in perpetuity, so long as the subject information is deemed confidential.
