### Inspector General's Office

- IC 4-2-7-2 IG "Enabling Statute"
  - "...responsible for addressing <u>fraud</u>, waste, abuse, and <u>wrongdoing in agencies</u>."
- Discussion:
  - Agency referral to Administration??
  - Immediate Consideration---should the IG's Office be included?? (WHY?)
    - If so, get involved early!!

# Document Everything



### Document Everything

- Initial Complaint
  - Date/ time/ Location/ Who
- If criminal charges possible, Collect Evidence ASAP
- WHO will testify to this Evidence??
- Assume Nothing!
  - "Everybody Knows It!" doesn't work in Court

#### Documentation

- Scanned Docs submitted
  - True/ fraudulent?—HOW Falsified?
  - Check bank account activity
  - History on accounts + case files
    - Changes in Pattern



### Verify Documentation

- Scanned Docs: True or False???
  - Bank Records
  - Employer Records
    - Personnel File
    - Payroll Checks
  - Landlord Records
    - Lease/ Who signed on as resident
    - How long at residence
    - Amount of Rent

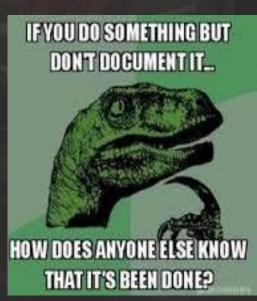
### **Vendor Documentation**

- Contract Vendor (Xerox)
- Did Vendor provide Service Benefit?
- Double Billing?

### More Documentation

#### IDENTITY

- Bank Records—obtain "opening account" records w/ Signature Card
- Verify EBT funds deposited in his account
- History of EBT transactions
  - Follow up w/ Merchant
  - Obtain Receipts/ all paperwork



### Even More Documentation

Video/ Surveillance Recording

- Grocery Store/ Pharmacy w/ Suspect using

EBT card!



# State Employee is Suspect

- Personnel File
  - Position
  - Duties/ Responsibilities

- Check their Office/ Work Station
  - Photograph items before moving anything
  - Collect/ Record Everything

### Civil Approach

- State Agency enters a Restitution Agreement w/ Suspect
  - Restitution payments begin

- Restitution Agreement may be held to foreclose Criminal Prosecution
  - Screening Prosecutor may refuse to file criminal charges
  - Consider -before entering into agreement

### When to interview the Suspect?

- Agency: Immediate!!
  - Get rid of Crook in Agency
- Investigation:
  - IG: need Time for Preparation
  - Best Access while suspect is available
  - Record Interview
  - Agency Rep present?
    - Valuable Information asset

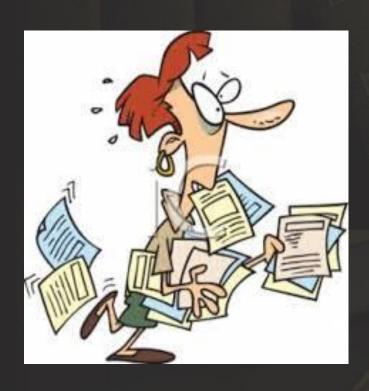

### Screening Documents

- Probable Cause in "PDF" format
  - Electronically signed "/s/\_\_\_\_\_"
- Redacted PC, if required
- Case Information Sheet
  - Suspect Identifiers + Witness Contact info
- Suspect's Criminal History
- Incident/ Case Report
- All other docs in file will be scanned into <u>PCMS "Detective Packet"</u>
