**Nature of Business Relationship with Agency:**

BMV currently maintains a business relationship with ITI for the production and distribution of license plates and registration documentation, automated knowledge testing services, and self-service kiosks.

**Why acceptance is in the Public Interest:**

BVM held a Winter Leadership Meeting for its management staff on January 15-16, 2019. Attendees reviewed the agency's accomplishments in 2018 and initiatives planned for 2019. Activities included individual presentations followed by question and answers sessions, brainstorming discussions, leadership development, and team building exercises.

ITI was invited to present an educational program during dinner on January 15, 2019 that provided an overview of its efforts in 2018, activities that were planned for 2019, and sought input on any service issues/complaints that employees were having in the field. ITI employees also stayed after dinner to allow for one-on-one interaction so as to continue the dialogue amongst those in attendance that had further questions.
