Order 2022-79 involved a settlement agreement with CSI Operating Company, LLC d/b/a Caesars Southern Indiana (Caesars Southern Indiana) and includes nine counts. In count one, the casino violated their internal control procedures on child support arrears delinquency reporting (CSADR). In count two, the casino allowed an underage person on the casino floor.
