### INDIANA GAMING COMMISSION BUSINESS MEETING

June 29, 2017 Indiana State Library, Historical Reference Room Indianapolis, Indiana

### Call to Order and Roll Call:

Chairman Cris Johnston called the meeting to order at 1:03 p.m. local time. A quorum was present.

#### Present:

Commission members: Cris Johnston, Chairman, Marc Fine, Vice Chairman, Joseph Svetanoff, Secretary, Susan Williams, Charles M. Herndon, and Rich McClain. Commission staff: Sara Tait, Jenny Reske, Greg Small, Kimi Simpson, Angela Bunton, Noah Jackson, Dennis Mullen, Rob Townsend, Frank Brady, Bill Murphy, Dana Coleman, Sherry Green, Robert Paugh, Tom Stuper, Danielle Leek, Diane Freeman, Amber Shover, Marecia Dewar, and members of the public.

### Approval of the Minutes:

Upon motion by Joseph Svetanoff, second by Mike Herndon, and unanimous vote of those present, the Commission approved the proposed minutes from the March 23, 2017 Business Meeting.

### Report of the Executive Director:

The Executive Director began her report by providing a staff update: Amber Shover joined Charity Gaming. Angela Bunton was promoted to Director of Compliance, Marecia Dewar was promoted to Assistant Director of Compliance, Jeremy Hosier was promoted to Background Investigator, and Dan Hirst was promoted to Deputy Superintendent of Law Enforcement. Then, she announced the reorganization of the law enforcement divisions, resulting in the promotion of Nick Rentas to North Assistant Director and Jonnie Hudson to Majestic Star Supervisor. Executive Director Tait also announced the new Assistant Supervisors, new positions created in the reorganization: Anthony Edwards at Majestic Star, Sean DeMuth at Ameristar, Geoff Jania at Blue Chip, Louis Molina at Horseshoe Hammond, Greg Lee at Indiana Grand, Brian Beard at Rising Star, Ty Shoopman at Hoosier Park, David Whitesell at Hollywood, Andrea Potter at French Lick, Karla Friese at Tropicana, and Chad Daggy at Horseshoe South.

### Waiver of Rules and Regulations:

**Blue Chip, Hoosier Park, Horseshoe Hammond and Rising Star:** Granted waivers to employ 18-20 year olds in certain job positions.

**Blue Chip:** Granted a request to move all active and one year termed team member files to an off-site, out of state location.

French Lick: Granted a limited waiver of 68 IAC 1-7-1 due to their unique location.

<u>Hollywood:</u> Allowed utilize multi-deck, pre-shuffled cards and players are allowed to touch the cards at all baccarat table games and variations. Patrons are also allowed to alter cards as they will only be in play one time.

<u>Horseshoe Southern Indiana:</u> Granted a request to add a one hundred thousand dollar World Series of Poker tournament chip.

Horseshoe Hammond and Horseshoe Southern Indiana: Granted a request to allow a hand to be kept in action if a card should be found face upward in the baccarat shoe rather than burning the card during the play. Additionally, they were granted a request to allow employees to display an alternate name on their gaming badges under limited conditions.

<u>Majestic Star:</u> Allowed to utilize 20 additional traveling Dealers for the America's Poker Tour event and utilize RFID playing cards at the final table.

<u>Casino Association:</u> Granted a request that all multi-deck, pre-shuffled playing cards be verified for quantity and suit on every 20th pre-shuffled shoe. Additionally, the Casino Association is allowed to increase the maximum amount of impressment for slot pouches to \$20,000 for a six month trial period and to perform the rotation of primary chips \$25 or below twice weekly. They were also granted a request to use toke tubes for \$25 or less.

<u>All Casinos:</u> Granted a request to eliminate the badging replacement fee for occupational licensees.

Since the March 2017 Business Meeting, Commission staff has added 15 individuals to the Exclusion List, which effectively and permanently bars those patrons from entering any casino in Indiana.

Of those 15 individuals, 4 were placed on the list for cheating, 3 were placed on the list for past-posting, pinching, or capping bets. Eight were placed on the list for conducting jackpot switches or using false identification to claim a jackpot. The final 3 individuals were placed on the list for conducting an activity deemed to adversely affect public confidence and trust in gaming. For the year 2017, the Commission has placed 38 patrons on the list, bringing the total to 668 individuals.

Executive Director Tait then reported the approval and partial waiver of 68 IAC 5-3-2 to Full House for a refinancing package that was proposed by the company, since official action of the Commission was taken. Full House subsequently requested withdrawal of the interim approval. She then thanked the representatives from the Paid Fantasy Sports applicants and Caesars Entertainment for traveling to the meeting to address the Commissioners.

Lastly, Executive Director Tait praised the Commission staff, particularly the Legal and Investigation Divisions, for undertaking two large projects, which coincided at the same time, on a tight timeline, and doing a wonderful job. She also thanked Mike Hile for providing legal counsel to the commission for the two and a half year Caesars bankruptcy process.

A settlement agreement with The Majestic Star Casino, LLC includes three counts, Count 1: the casino violated the rule for the soft count process, and Count 2: the casino violated the rule on the central computer system and failed to provide notice to the Commission when the casino is conducting system maintenance on the central computer system, and Count 3: the casino violated the rule requiring surveillance to audibly record the soft count process on two occasions. Majestic Star agreed to a monetary settlement of \$16,000 in lieu of disciplinary action.

### ORDER 2017-102 IN RE SETTLEMENT AGREEMENT GAMING ENTERTAINMENT (INDIANA), LLC 17-RR-02

A settlement agreement with Gaming Entertainment (Indiana), LLC ("Rising Star") includes two counts, Count 1: the casino violated their internal control procedures for the drop process by allowing a patron to walk through the designated drop area while the drop was in process, and Count 2: the casino violated the surveillance rules as slot storage was not being recorded. Rising Star agreed to a monetary settlement of \$3,500 in lieu of disciplinary action.

### ORDER 2017-103 IN RE SETTLEMENT AGREEMENT AZTAR INDIANA GAMING CO., LLC 17-AZ-02

A settlement agreement with Aztar Indiana Gaming Co., LLC ("Tropicana Evansville") includes two counts, Count 1: the casino violated a rule on electronic gaming devices when the integrity of the electronic gaming device had been questioned and the casino also failed to notify Enforcement Agents that an electronic gaming device had been removed from play, and Count 2 the casino violated the rule on table games fill and credit procedures.
