MINUTES OF THE SEPTEMBER 18, 2014 INDIANA GAMING COMMISSION BUSINESS MEETING

Indiana State Library History Reference Room

CALL TO ORDER AND ROLL CALL:

Chairman Matt Bell called the meeting to order at 2:09 p.m. local time. A quorum was present.

APPROVAL OF THE MINUTES:

Upon motion by Marc Fine, seconded by Susan Williams, and unanimous vote of those present, the Commission approved the proposed minutes from the June 26, 2014, Business Meeting.

REPORT OF THE EXECUTIVE DIRECTOR:

Staff Update: The Executive Director began his report with the re-introduction of Sara Gonso Tait and her new position of General Counsel. Derek Young succeeded Sara as the License Control Counselor. Michelle Baldwin was welcomed to our legal staff on August 4th as Deputy General Counsel. Ed Harcourt was announced as our first Legal Analyst. Angela Bottom was introduces as our latest Occupational License Coordinator. Gaming Enforcement welcomed Carolyn Fabrie as Secretary. Heidi Justice was announced as Charity Gaming's newest Program Coordinator. Finally, the Director mentioned the newest addition to our staff was Raquel Selene Reske; her mother Jenny is scheduled to rejoin us in early November.

Reinvestigation Summary: Executive Director Yelton announced that the Background and Financial Investigation Division had completed their reinvestigation of Penn National, owner of Hollywood Casino. There were no questions from the Commissioners.

Waiver of Rules and Regulations:

<u>Casino Association</u>: Granted a 6 month waiver period from the requirement of the soft count team to notify surveillance prior to the initiation of the soft count. Security will provide notification to surveillance when the soft count team enters the soft count room.

<u>Belterra and Ameristar</u>: Granted a waiver from maintaining a history of credit issuances and payments received in the physical patron file. Both casinos will use an electronic credit and collection file.

<u>Belterra</u>: Allowed to remove surveillance equipment from the IGC office on the vessel given that the Gaming Agents are able to perform the same job duties and functions in the IGC office located in the pavilion.

It was also granted relief from the established aggregated check threshold of ten thousand dollars (\$10,000) for a one week period. Belterra transitioned from one guarantee service provider to another and since both companies were not privy to the history of the checks cashed by the other company it is possible that the threshold between the two providers may have exceeded the thousand dollars.

<u>Blue Chip</u>: Allowed to order obsolete software for four electronic gaming devices due to compatibility issues with the current approved version.

It was further granted relief from the internal audit quarterly report submissions, observations, testing and examination of documents and instead will conduct a semi-annual internal audit. Blue Chip will submit its reports to the Commission Audit Director thirty (30) days after the close of the second quarter and thirty (30) days after the close of the fourth quarter.

<u>French Lick</u>: Granted relief from the requirement of the casino name imprinted on its current roulette wheel but none others.

Horseshoe Hammond and Horseshoe Southern Indiana: Granted relief from the requirement of placing the manual date and time stamp on checks cashed through the Caesar Entertainment CMS system. Negotiable items processed by the Cage Staff will be electronically stamped in the system and tied to the individual processing and approving the transaction.

They were also allowed to have the tip boxes dropped a minimum of three times per week.

<u>Horseshoe Hammond</u>: Granted a waiver of the size requirement for the SIC Bo Dice from 0.750 - 0.775 inch to 0.625 inch on each side and the requirement from square edges to ball corner edges.

It also received a waiver to coin test 50% of the EGDs once they are placed back on the floor after their removal for a carpet replacement. This waiver was a one-time approval and was granted for this project only.

Horseshoe Southern Indiana: Granted relief for non-gaming employees working in areas other than the gaming vessel to wear only their company issued name tag for identification purposes and to carry their gaming badge with them should they need to produce it.

<u>Majestic Star and Tropicana</u>: Granted waivers for the use of an RFID table and cards for the final table at the Mid States Poker Tournament.

<u>Tropicana</u>: Granted relief from the requirement for card inspections for pre-shuffled cards used in blackjack, non-handheld games. The casino will continue to verify quantity, suit and inspect the back of the cards for one of every ten pre-shuffled shoes.

French Lick has agreed to a total monetary settlement of \$23,000 in lieu of a disciplinary action.
