Report of the Executive Director:

The Executive Director began her report by thanking Mr. John Chaszar and his team for hosting the Indiana Gaming Commission today. She then provided a staff update: Dustin Moloy as staff attorney; Stephanie Gardner as VEP Coordinator; and Omavi Caesar as Occupational Licensing Coordinator. She also welcomed four new Gaming Agents stationed in the Southern Zone. She also added that the Background and Financial Investigations Divisions conducted reinvestigations of casino licensee Hollywood and suppliers Everi, IGT, and SuzoHapp which are included in the confidential materials. The Executive Director indicated that, moving forward, the exclusion and waiver reports will not be fully included during her verbal report. The details regarding the IGC staff actions have been provided in the Commission's materials and will be posted on the IGC's website. Since the June Meeting, there have been 11 waivers of IGC regulations issued to casinos and IGC staff has added 17 individuals to the exclusion list.


