

RESOLUTION 1994-29

**A RESOLUTION ADOPTING AND PRESCRIBING THE
OCCUPATIONAL LICENSE, LEVEL 2 APPLICATION
FORM FOR THE INDIANA GAMING COMMISSION**

WHEREAS, the Indiana Gaming Commission ("the Commission") has the power and duty under IC 4-33-4-1 to fully and effectively execute IC 4-33 ("the Riverboat Gambling Law");

WHEREAS, the Commission has the power and duty to take any reasonable and appropriate action to enforce the Riverboat Gambling Law;

WHEREAS, pursuant to IC 4-33-4-5 and IC 4-33-8, the Commission has the power and duty to issue occupational licenses;

WHEREAS, pursuant to IC 4-33-4-1, the Commission is to prescribe the form to be used by riverboat licensees to evaluate potential employees;

WHEREAS, the Commission has been duly advised in the matter and finds that the Commission should act promptly to prescribe the Occupational License, Level 2 Application Form so that an applicant for an Occupational License, Level 2 may initiate the application process;

WHEREAS, the Commission has published proposed rules to regulate occupational licenses at 68 IAC 2-3 (Indiana Register, Volume 17, Number 9, June 1, 1994) and has adopted those rules pursuant to RESOLUTION 1994-14.

NOW, THEREFORE, BE IT RESOLVED BY THE INDIANA GAMING COMMISSION THAT THE FOLLOWING RESOLUTION IS ADOPTED:

SECTION 1. DEFINITIONS.

The definitions set forth in IC 4-33-2 and 68 IAC 1-1 (adopted pursuant to RESOLUTION 1994-14) apply to this resolution.

SECTION 2. OCCUPATIONAL LICENSE, LEVEL 2 APPLICATION FORM ADOPTED.

The Indiana Occupational License, Level 2 Application Form is adopted. A copy of the form is incorporated into this RESOLUTION by reference, and is attached to this RESOLUTION and designated as "EXHIBIT A".

SECTION 3. MANNER AND LOCATION OF FILING.

Pursuant to 68 IAC 2-3-4 (adopted pursuant to RESOLUTION 1994-14) an applicant for an Occupational License, Level 2 must submit the original application and all requested materials to the Commission agent at the appropriate dock site.

SECTION 4. EFFECTIVE DATE.

This resolution is effective immediately.
