

RESOLUTION 1996-21

A RESOLUTION ADOPTING ARTICLE 1, RULE 12; ARTICLE 11, RULE 7; ARTICLE 14, RULE 16; ARTICLE 15, RULE 11; ARTICLE 16, RULE 1 FOR PUBLICATION AS PROPOSED RULES.

The Indiana Gaming Commission (“Commission”) adopts the following resolution pursuant to the authority granted to it under IC 4-33 and pursuant to 68 IAC 1-2-6.

The following factors have been considered by the Commission:

1. The Commission has begun promulgation on the majority of these rules pursuant to IC 4-22. These rules are to be published in the *Indiana Register* on May 1, 1996. A public hearing is to be held on these rules in compliance with IC 4-22. The Commission will begin the promulgation process on 68 IAC 14-16 on May 1, 1996.
2. The process for the final promulgation of these rules will take approximately four (4) to six (6) months.

NOW, THEREFORE, BE IT RESOLVED BY THE INDIANA GAMING COMMISSION, THAT THE FOLLOWING RESOLUTION IS ADOPTED:

SECTION 1. SCOPE.

This resolution applies to each applicant, each licensee, each riverboat license applicant, any person who does business with an applicant or licensee, and any person who is a patron of a Riverboat Gambling Operation.

SECTION 2. DEFINITIONS.

The definitions set forth in IC 4-33-2 and 68 IAC apply to this resolution.

SECTION 3. ADOPTION OF THE PROPOSED RULES.

The Commission adopts the following proposed rules pending the promulgation process:

- Rule 12 Complimentary Chip and Token Distribution Programs

Article 11 Internal Control Procedures
Rule 7 Sensitive Key Control

Article 14 Gaming Equipment

Rule 11 Electronic Gaming Device Hopper Fills and Credits

Article 16 Credit
Rule 1 General Provisions

The Commission adopts the rules which are being forwarded to the Legislative Services Agency on or before May 1, 1996, and further adopts any stylistic, grammatical, typographical, or other nonsubstantive changes which the Commission or the Legislative Services Agency may make to these rules. The Commission adopts the rule for which a notice of intent will be filed on May 1, 1996 and further adopts any stylistic, grammatical, typographical, or other nonsubstantive changes which the Commission or the Legislative Services Agency may make to these rules. The Commission adopts the amendments to 68 IAC 1-1-54 and 68 IAC 2-1-7 and further adopts any stylistic, grammatical, typographical, or other nonsubstantive changes which the Commission or the Legislative Services Agency may make to these rules.

SECTION 4. EFFECTIVE DATE.

This RESOLUTION is effective immediately.

SECTION 5. EXPIRATION DATE.


This RESOLUTION expires thirty (30) days from the date and time that the Secretary of State accepts the rules listed in Section 3 for filing.
