

RESOLUTION 1997- 29

**A RESOLUTION ADOPTING, AS FINAL RULES,
68 IAC 10-4 AND AMENDMENTS TO 68 IAC 2-2-1.**

The Indiana Gaming Commission ("Commission") adopts the following resolution pursuant to the authority granted to it under IC 4-33 and pursuant to 68 IAC 1-2-6.

The following factors have been considered by the Commission:

1. The Commission has begun promulgation of these rules pursuant to IC 4-21.5. The amendments to 68 IAC 2-2-1 were published in Volume 20 of the *Indiana Register*, pages 1773 through 1774, on April 1, 1997. 68 IAC 10-4 was published in Volume 20 of the *Indiana Register*, pages 2837 through 2844 on July 1, 1997.
2. The Commission held a public hearing on the amendments to 68 IAC 2-2-1 on April 24, 1997, and accepted written comment on the same. The Commission held a public hearing on 68 IAC 10-4 on July 29, 1997, and accepted written comments on the same. The verbal comments from the public hearings were transcribed, and the transcript as well as the written comments have been provided to the Commission members for review.
3. The promulgation process for the final promulgation of these rules will take approximately four (4) to six (6) months.
4. The amendments to 68 IAC 2-2-1 were previously adopted as final rules by the Commission on June 13, 1997. Changes were made to this rule based on comments provided by the Attorney General's Office during the review process. This rule was recalled and will now be resubmitted to the Attorney General's Office.

NOW, THEREFORE, BE IT RESOLVED BY THE INDIANA GAMING COMMISSION, THAT THE FOLLOWING RESOLUTION IS ADOPTED:

SECTION 1. SCOPE.

This resolution applies to each applicant, each licensee, each riverboat license applicant, any person who does business with an applicant or licensee, and any person who is a patron of a Riverboat Gambling Operation.

SECTION 2. DEFINITIONS.

The definitions set forth in IC 4-33-2 and 68 IAC apply to this resolution.

SECTION 3. ADOPTION OF THE FINAL RULES.

The Commission adopts the following final rules pending completion of the promulgation process:

Article 2 Licenses; Approval of Associated Equipment
68 IAC 2-2-1 Supplier's license required.

Article 10 Conduct of Gaming
68 IAC 10-4 Craps

Pursuant to IC 4-22-2-27 through IC 4-22-2-30, the Commission adopts the rules which will be forwarded to the Attorney General's Office on or before August 29, 1997 for approval as final rules pursuant to IC 4-22-2-32. Upon approval by the Attorney General's Office, the rules will be submitted to the Governor's office for approval pursuant to IC 4-22-2-33. After the rules have been approved or deemed approved by the Governor, the rules shall be submitted to the Secretary of State for filing in accordance with IC 4-22-2-35. The Commission further adopts any stylistic, grammatical, typographical, or other nonsubstantive changes which the Commission or the Legislative Services Agency may make before the rules are printed as final rules in the *Indiana Register*.

SECTION 4. EFFECTIVE DATE.


This RESOLUTION is effective immediately.

This RESOLUTION expires thirty (30) days from the date and time that the Secretary of State accepts the rules listed in Section 3 for filing.


