RESOLUTION 1999-3

A RESOLUTION CONCERNING THE RENEWAL OF SUPPLIER'S LICENSES

The Indiana Gaming Commission ("Commission") adopts the following resolution pursuant to the authority granted to it under IC 4-33 and pursuant to 68 IAC 1-2-6:

The following factors have been considered by the Commission:

1. On October 22, 1997, by RESOLUTION 1997-36, a Permanent Supplier's License was issued to GDC, Inc.

On December 15, 1997, by RESOLUTION 1997-46, a Permanent Supplier's License was issued to International Electronic Protection ("IEP").

On January 20, 1998, by RESOLUTION 1998-2, a Permanent Supplier's License was issued to IGT.

On March 17, 1998, by RESOLUTION 1998-7, Permanent Supplier's License was issued to WMS Gaming, Inc., Lodging & Gaming Systems, Inc. and Anchor Coin.

- 2. In accordance with IC 4-33-7-8 and 68 IAC 2-2-8, a Supplier's License must be renewed annually.
- 3. The above named supplier licensees have requested a renewal of the Supplier's License and paid the renewal fee in accordance with 68 IAC 2-2-3(c) and 68 IAC 2-2-8.
- 4. The Commission has determined that the above named supplier licensees are in compliance with IC 4-33.

The Commission hereby grants the renewal of the Supplier's Licenses issued to the suppliers listed below. The renewed supplier's licenses will be valid for a period of one (1) year, from date of issuance.
