

## **RESOLUTION 1999-25**

### **CONDITIONAL APPROVAL OF THE GAME OF SPANISH 21**

The Indiana Gaming Commission (“Commission”) adopts the following resolution pursuant to the authority granted to it under IC 4-33 and pursuant to 68 IAC 1-2-6.

The following factors have been considered by the Commission:

1. IC 4-33-2-9 and 68 IAC 10-1-1 set forth those games that are approved for use in Indiana. IC 4-33-2-9 authorizes the game of Blackjack in Indiana, see also 68 IAC 10-1-1.
2. Masque Publishing submitted the game of “Spanish 21” and asked that the Commission consider approving it for use in Indiana.
3. Majestic Star, Grand Victoria, and Trump have advised the Commission, in writing, that they support the game of “Spanish 21” for use in Indiana. Each boat has submitted a draft of rules of the game that they propose to utilize if the game of “Spanish 21” is approved.
4. Gaming Laboratories International, Inc. (“GLI”) has reviewed the information and material submitted by Masque Publishing. GLI has forwarded its report to the Commission and has found that the game of “Spanish 21” is a variation of the traditional game of Blackjack.

**NOW, THEREFORE, BE IT RESOLVED BY THE INDIANA GAMING COMMISSION, THAT THE FOLLOWING RESOLUTION IS ADOPTED:**

#### **SECTION 1. SCOPE.**

This resolution applies to all riverboat licensees and Masque Publishing.

#### **SECTION 2. DEFINITIONS.**

The definitions set forth in IC 4-33-2 and 68 IAC apply to this resolution.

#### **SECTION 3. CONDITIONAL APPROVAL OF THE GAME OF “Spanish 21”.**

The game of “Spanish 21” is approved for a trial period of six (6) months for use on Indiana riverboats. During the trial period, all riverboats who offer the game of “Spanish 21” must have pre-approved rules of the game and must report those matters as directed by the Executive Director or the Executive Director’s designee, which matters include, but are not limited to, the following information: the amount of play, the revenue generated by the game of “Spanish 21”, and whether the riverboat licensee wishes to continue offering the game of

“Spanish 21”. The riverboat licensee must also document any customer complaints or incidents that are generated by the game of “Spanish 21” and forward those reports to the Commission. At the end of the trial period, the Commission will consider approving the game of “Spanish 21” to be offered on Indiana Riverboats on a permanent basis.

**SECTION 4. EFFECTIVE DATE.**

This RESOLUTION is effective immediately.
