

RESOLUTION 1999-26

CONDITIONAL APPROVAL OF THE GAME OF BLACKJACK DOUBLE EXPOSURE

The Indiana Gaming Commission (“Commission”) adopts the following resolution pursuant to the authority granted to it under IC 4-33 and pursuant to 68 IAC 1-2-6.

The following factors have been considered by the Commission:

1. IC 4-33-2-9 and 68 IAC 10-1-1 set forth those games that are approved for use in Indiana. IC 4-33-2-9 authorizes the game of Blackjack in Indiana, see also 68 IAC 10-1-1.
2. Grand Victoria Casino & Resort (“Grand Victoria”) has advised the Commission, in writing, that it supports the game of Blackjack Double Exposure for use in Indiana, and Grand Victoria has submitted a draft of proposed rules of the game which it proposes to utilize if the game is approved.
3. Gaming Laboratories International, Inc. (“GLI”) has reviewed the information and material submitted by Grand Victoria. GLI has forwarded its report to the Commission and has found that the game of Blackjack Double Exposure is a variation of the traditional game of Blackjack.

NOW, THEREFORE, BE IT RESOLVED BY THE INDIANA GAMING COMMISSION, THAT THE FOLLOWING RESOLUTION IS ADOPTED:

SECTION 1. SCOPE.

This resolution applies to all riverboat licensees.

SECTION 2. DEFINITIONS.

The definitions set forth in IC 4-33-2 and 68 IAC apply to this resolution.

SECTION 3. CONDITIONAL APPROVAL OF THE GAME OF BLACKJACK DOUBLE EXPOSURE.

The game of Blackjack Double Exposure is approved for a trial period of six (6) months for use on Indiana riverboats. During the trial period, all riverboats who offer the game of Blackjack Double Exposure must have pre-approved rules of the game and must report those matters as directed by the Executive Director or the Executive Director’s designee, which matters include, but are not limited to, the following information: the amount of play, the revenue generated by the game of Blackjack Double Exposure, and whether the riverboat

licensee wishes to continue offering the game of Blackjack Double Exposure. The riverboat licensee must also document any customer complaints or incidents that are generated by the game of Blackjack Double Exposure and forward those reports to the Commission. At the end of the trial period, the Commission will consider approving the game of Blackjack Double Exposure to be offered on Indiana Riverboats on a permanent basis.

SECTION 4. EFFECTIVE DATE.

This RESOLUTION is effective immediately.
