RESOLUTION 1999-34

CONDITIONAL APPROVAL OF THE GAME OF WILD ARUBA STUD

The Indiana Gaming Commission ("Commission") adopts the following resolution pursuant to the authority granted to it under IC 4-33 and pursuant to 68 IAC 1-2-6.

The following factors have been considered by the Commission:

- 1. IC 4-33-2-9 and 68 IAC 10-1-1 set forth those games that are approved for use in Indiana. Both IC 4-33-2-9 and 68 IAC 10-1-1 authorize the game of Poker in Indiana.
- 2. Mikohn Gaming Corporation has submitted the game of Wild Aruba Stud and has asked that the Commission consider approving it for use in Indiana.
- 3. Trump Indiana ("Trump") has advised the Commission, in writing, that it supports the game of Wild Aruba Stud for use in Indiana, and Trump has submitted a draft of proposed rules of the game which it proposes to utilize if the game of Wild Aruba Stud is approved.
- 4. Gaming Laboratories International, Inc. ("GLI") has reviewed the information and material submitted by Mikohn Gaming Corporation. GLI has forwarded its report to the Commission and has found that the game of Wild Aruba Stud is a variation of the traditional game of Poker.

NOW, THEREFORE, BE IT RESOLVED BY THE INDIANA GAMING COMMISSION, THAT THE FOLLOWING RESOLUTION IS ADOPTED:

SECTION 1. SCOPE.

This resolution applies to all riverboat licensees and Mikohn Gaming Corporation.

SECTION 2. DEFINITIONS.

The definitions set forth in IC 4-33-2 and 68 IAC apply to this resolution.

SECTION 3. CONDITIONAL APPROVAL OF THE GAME OF WILD ARUBA STUD.

The game of Wild Aruba Stud is approved for a trial period of six (6) months for use on Indiana riverboats. During the trial period, all riverboats who offer the game of Wild Aruba Stud must have pre-approved rules of the game and must report those matters as directed by the Executive Director or the Executive Director's designee, which matters include, but are not limited to, the following information: the amount of play, the revenue generated by the game of Wild Aruba Stud, and whether the riverboat licensee wishes to continue offering the game of

Wild Aruba Stud. The riverboat licensee must also document any customer complaints or incidents that are generated by the game of Wild Aruba Stud and forward those reports to the Commission. At the end of the trial period, the Commission will consider approving the game of Wild Aruba Stud to be offered on Indiana Riverboats on a permanent basis.

SECTION 4. EFFECTIVE DATE.

This RESOLUTION is effective immediately.
