

## **RESOLUTION 2004-46**

### **A RESOLUTION DENYING A SUPPLIER'S LICENSE TO GLOBAL SURVEILLANCE ASSOCIATES**

The Indiana Gaming Commission (Commission) adopts the following resolution pursuant to the authority granted to it under IC 4-33 and pursuant to 68 IAC 1-2-6.

The Commission has considered the following factors:

1. Global Surveillance Associates was advised via email on or about November 24, 2003 that a Supplier's License was necessary to supply surveillance equipment to Harrah's East Chicago Casino ("Harrah's"). Pursuant to 68 IAC 2-21(c), suppliers of security services, security systems, and surveillance systems are required to hold a Supplier's License. Global Surveillance Associates acknowledged receipt of the application materials via email on November 26, 2003.
2. On or about December 1, 2003, Global Surveillance Associates submitted an application to the Commission for a Supplier's License. The application and fee were received by the Commission on or about December 8, 2003.
3. An investigation regarding Global Surveillance Associate's application was conducted and issues were revealed relative to Global Surveillance Associate's suitability for obtaining a Supplier's License.
4. Global Surveillance Associate's application was turned over to the Commission's Background Investigation Unit in December 2003 for investigation. In January 2004, Commission agents at Harrah's notified Commission staff that Global Surveillance Associates had been performing duties at Harrah's during November and December of 2003. Vendor logs received from Harrah's verify this information. Specifically, Global Surveillance Associates performed duties at Harrah's on nine separate days from November 24, 2003, the date they were advised that a Supplier's License was required, and December 31, 2003.
5. At no time relevant to this matter did the Commission issue a Supplier's License, either temporary or permanent, to Global Surveillance Associates.
6. Pursuant to Settlement Agreement 04-HA-1, Harrah's remitted a fine in the amount of \$5,000 to the Commission for conducting business with Global Surveillance Associates without proper licensure from the Commission.
7. Upon review of the information uncovered during the investigation, Commission staff has determined that Global Surveillance Associates is not suitable to hold a Supplier's License.

**NOW, THEREFORE, BE IT RESOLVED BY THE INDIANA GAMING COMMISSION, THAT THE FOLLOWING RESOLUTION IS ADOPTED:**

**SECTION 1: SCOPE**

This resolution applies to Global Surveillance Associates.

**SECTION 2: DEFINITIONS**

The definitions set forth in IC 4-33-2 and 68 IAC apply to this resolution.

**SECTION 3: DENIAL OF APPLICATION FOR A SUPPLIER'S LICENSE**

The Commission hereby denies the application for a Supplier's License submitted by Global Surveillance Associates.

**SECTION 4: EFFECTIVE DATE**

This resolution is effective immediately.
