

RESOLUTION 2006-81

A RESOLUTION ADOPTING LSA DOCUMENT #06-190 AS A FINAL RULE

The Indiana Gaming Commission ("Commission") adopts the following resolution pursuant to the authority granted to it under IC 4-33 and pursuant to 68 IAC 1-2-6.

The Commission has considered the following factors:

1. The Commission began promulgation of these rules pursuant to IC 4-22. The *Indiana Register* published the proposed rules in the August 23, 2006 edition available online as DIN 20060823-IR-068060190PRA, at <http://www.in.gov/legislative/register/irtoc.htm>.
2. The Commission held a public hearing on these rules on September 22, 2006 in compliance with IC 4-22. There were no written or oral comments made at the hearing or otherwise properly received.
3. If the Commission approves this Resolution adopting the attached rule document as a final rule, the rule will be forwarded to the Office of the Attorney General and the Governor for approval, and filed thereafter with the *Indiana Register*. The rule will be effective 30 days after it is filed with the *Indiana Register*.

NOW, THEREFORE, BE IT RESOLVED BY THE INDIANA GAMING COMMISSION, THAT THE FOLLOWING RESOLUTION IS ADOPTED:

SECTION 1: SCOPE

This resolution applies to all persons and entities licensed by the Commission, all persons or entities that have applied to the Commission for licensure, all operating agents or operating agent applicants, any person who does business with a licensee, license applicant, operating agent, or operating agent applicant, any person who is a patron of a Riverboat Gambling Operation, and any other individual who may be present in a licensed gaming facility at any time.

SECTION 2: DEFINITIONS

The definitions set forth in IC 4-33-2 and 68 IAC apply to this resolution.

SECTION 3: ADOPTION OF THE PROPOSED RULES AND AMENDMENTS

The Commission adopts the following as final rules pending completion of the promulgation process:

68 IAC 1-7-1 Weapons on the riverboat

68 IAC 1-7-2 Waiver of requirements

Pursuant to IC 4-22-2, the Commission adopts the attached rule document as a final rule. The rule will be forwarded to the Office of the Attorney General for approval as to legality under IC 4-22-2-32. Upon approval by the Office of the Attorney General, the rule will be submitted to the Office of the Governor for approval pursuant to IC 4-22-2-33. After the rule has been approved or deemed


approved by the Governor, the rule will be submitted to the *Indiana Register* for filing in accordance with IC 4-22-2-35. The Commission further adopts any stylistic, grammatical, typographical, or other non-substantive changes which the Commission, the Office of the Attorney General, or the Legislative Services Agency may make before the amendment to the rule is printed as a final rule in the *Indiana Register*.

SECTION 4: EFFECTIVE DATE

This RESOLUTION is effective immediately.
