

## ORDER 2007-111

### AN ORDER OF THE INDIANA GAMING COMMISSION CONCERNING THE RENEWAL OF SUPPLIER LICENSES

The Indiana Gaming Commission ("Commission") adopts the following order pursuant to authority granted it under IC 4-33.

In accordance with and subject to Indiana Code 4-33 and 68 IAC 2-2 of the Indiana Administrative Code, the Indiana Gaming Commission ("Commission") has previously issued permanent supplier licenses to: (1) Aristocrat Technologies, Inc. (2) Benchmark Hospitality of Indiana, Inc. (3) Paltronics, Inc. (4) Southwest Surveillance Systems (5) Chipco International.

A supplier license is valid for a period of one (1) year and in accordance with IC 4-33-7-8 and 68 IAC 2-2-8, a supplier license must be renewed annually along with the payment of Five Thousand Dollars (\$5,000) for the annual renewal fee.

Each of these licensees has requested renewal of licensure and the renewal fees have been paid in accordance with 68 IAC 2-2-3(c) and 68 IAC 2-2-8. The Commission has determined that the supplier licensees named herein remain in substantial compliance with IC 4-33 and are suitable to hold a supplier license.

The Commission hereby **GRANTS** renewal of the licenses of each of the following suppliers for a period of one year as specified below:

- 1) Aristocrat Technologies, Inc.: valid November 9, 2007 through November 8, 2008
- 2) Benchmark Hospitality of Indiana, Inc.: valid September 14, 2007 through September 13, 2008
- 3) Paltronics, Inc.: valid November 17, 2007 through November 16, 2008
- 4) Southwest Surveillance Systems: valid December 3, 2007 through December 2, 2008


The Commission **GRANTS** renewal of the license of Chipco International for a period of one year, from October 23, 2007 through October 22, 2008, conditioned upon Chipco International satisfying all outstanding balances and accounts owed to the Indiana Gaming Commission for costs associated with an investigation of the licensee pursuant to IC 4-33-7-8. Chipco International shall establish terms of payment acceptable to the Executive Director within ten (10) days of the effective date of this order. If Chipco International fails to timely establish acceptable repayment terms, or fails to satisfy such terms, as determined by the Executive Director, then the renewal of the license of Chipco International may be deemed null and void by the Commission.

Each licensee shall be responsible for notifying the Commission of its desire to be considered for a subsequent license renewal at least thirty (30) days before the expiration of the license.


Pursuant to IC 4-21.5-3, this order is effective fifteen (15) days after the order is served.
