## ORDER 2008-117

## AN ORDER OF THE INDIANA GAMING COMMISSION CONCERNING THE VOLUNTARY EXCLUSION PROGRAM CASE NO. VEP-08-51

On or about May 11, 2007, John Doe #51 submitted an application to the Indiana Gaming Commission ("Commission") to participate in the Voluntary Exclusion Program for a minimum of five years. Pursuant to 68 IAC 6-3-2(g), a participant in the program agrees that if he or she violates the terms of the program and enters the gaming area of a facility under the jurisdiction of the Commission, he or she agrees to forfeit any jackpot or thing of value won as a result of any wagers made in the casino. Forfeited winnings are to be withheld by the casino licensee and remitted to the Commission, which shall collect such funds as a fine levied against the individual for violating the terms of the program.

On or about August 27, 2008, John Doe #51 was discovered to be present at Argosy Casino ("Argosy"). At that time, John Doe #51 had \$45.00 in his possession. Argosy withheld the winnings as required by Commission regulations and the Commission staff now seeks Commission approval for remittance, less applicable taxes on the winnings, as a fine levied against John Doe #51.

## **COMMISSION ACTION**

The Commission, after having reviewed this matter:

## **APPROVES**

the remittance of the winnings in the amount of \$45.00, less applicable taxes, as a fine levied against John Doe #51.

Pursuant to IC 4-21.5-3-5, this ORDER becomes effective 15 days following receipt of the Order of the Indiana Gaming Commission.
