ORDER 2008-12

AN ORDER OF THE INDIANA GAMING COMMISSION CONCERNING THE VOLUNTARY EXCLUSION PROGRAM CASE NO. VEP-08-12

On or about June 16, 2006, John Doe #12 submitted an application to the Indiana Gaming Commission ("Commission") to participate in the Voluntary Exclusion Program for a minimum of one year. Pursuant to 68 IAC 6-3-2(d), if a patron does not request removal from the program after the expiration of the program term, he or she remains validly in the program. Pursuant to 68 IAC 6-3-2(g), a participant in the program agrees that if he or she violates the terms of the program and enters the gaming area of a facility under the jurisdiction of the Commission agrees to forfeit any jackpot or thing of value won as a result of a wager made at any facility under the jurisdiction of the Commission. Forfeited jackpots are to be withheld by the riverboat licensee and remitted to the Commission, which shall collect such funds as a fine levied against the individual for violating the terms of the program.

On or about December 22, 2007, John Doe #12 won a jackpot at Majestic Star Casino ("Majestic") in the amount of \$1,800.00. The patron had not requested removal from the program at the time. Majestic Star withheld the jackpot as required by Commission regulations and seeks Commission approval for remittance, less applicable taxes on the jackpot, as a fine levied against John Doe #12.
