ORDER 2008-51

AN ORDER OF THE INDIANA GAMING COMMISSION CONCERNING THE VOLUNTARY EXCLUSION PROGRAM CASE NO. VEP-08-27

On or about February 23, 2007, John Doe #27 submitted an application to the Indiana Gaming Commission ("Commission") to participate in the Voluntary Exclusion Program for lifetime exclusion. Pursuant to 68 IAC 6-3-2(g), a participant in the program agrees that if he or she violates the terms of the program and enters the gaming area of a facility under the jurisdiction of the Commission, he or she agrees to forfeit any jackpot or thing of value won as a result of a wager made at any facility under the jurisdiction of the Commission. Forfeited winnings are to be withheld by the riverboat licensee and remitted to the Commission, which shall collect the funds as a fine levied against the individual for violating the terms of the program.

On or about February 8, 2008, John Doe #27 was discovered to be present at Grand Victoria Casino ("Grand Victoria"). At that time, he had \$2,706.00 in his possession; \$2,700.00 from a jackpot and \$6.00 from a TITO ticket. Grand Victoria withheld the winnings as required by Commission regulations and seeks Commission approval for remittance, less applicable taxes on the winnings, as a fine levied against John Doe #27.
