#### RESOLUTION 2010-216

### FINDINGS OF GOOD FAITH EFFORT IN MEETING WOMEN BUSINESS ENTERPRISE EXPENDITURE GOALS

The Indiana Gaming Commission ("Commission") adopts the following resolution pursuant to the authority granted to it under IC 4-33, IC 4-35-11 and 68 IAC 3-3.

The Commission has considered the following factors:

- 1. Pursuant to IC 4-33-14-5, in 2007 the Commission conducted an industry-wide disparity study to assist the Commission in setting appropriate goals for expenditures by a casino licensee to certified minority and women business owned enterprises. As a result of that study, the Commission established a goal which requires each casino licensee to spend 10.9% of its total construction expenditures with a woman-owned business enterprise.
- 2. Pursuant to IC 4-33-14, IC 4-35-11, and 68 IAC 3, a casino licensee who fails to meet the established goal must either become compliant or must exhibit a good faith effort to meet the goal.
- 3. In 2009, Indiana Gaming Company, LLP ("Hollywood Casino") failed to meet the established goal. As required by IC 4-33-14, IC 4-35-11, and 68 IAC 3, it submitted to the Commission information regarding its effort to meet the goal. As provided in 68 IAC 3-3-10(b), the Commission considered a number of factors in determining whether the casino licensee exhibited a good faith effort.
- 4. Upon review of the information submitted by Hollywood Casino, the Commission finds that Hollywood Casino demonstrated a good faith effort to meet the established goal.

# NOW, THEREFORE, BE IT RESOLVED BY THE INDIANA GAMING COMMISSION, THAT THE FOLLOWING RESOLUTION IS ADOPTED:

#### **SECTION 1: SCOPE**

This resolution applies to the Indiana Gaming Commission and casino licensees under IC 4-33 and IC 4-35.

#### **SECTION 2: DEFINITIONS**

The definitions set forth in IC 4-33, IC 4-35, and 68 IAC apply to this resolution.

#### **SECTION 3: FINDING OF GOOD FAITH EFFORT**

Pursuant to IC 4-33-14, IC 4-35, and 68 IAC 3, the Commission finds that Ameristar, Blue Chip, and Horseshoe Southern Indiana have demonstrated a good faith effort in meeting the goals established by the Commission for construction related expenditures to women-owned business enterprises.

#### SECTION 4: EFFECTIVE DATE

This resolution is effective November 10, 2010.
