## ORDER 2012-171 AN ORDER OF THE INDIANA GAMING COMMISSION CONCERNING THE VOLUNTARY EXCLUSION PROGRAM CASE NO. VEP-12-105

On or about March 14, 2012, John Doe #105 submitted an application to the Indiana Gaming Commission ("Commission") to participate in the Voluntary Exclusion Program for a minimum of one year. Pursuant to 68 IAC 6-3-2(g), a participant in the program agrees that if he or she violates the terms of the program and enters the gaming area of a facility under the jurisdiction of the Commission he or she willingly forfeits any money or thing of value obtained from or owed to the participant by a casino. The casino must withhold forfeited monies or things of value and remit them to the Commission, which collects the funds.

On or about October 5, 2012, John Doe #105 was discovered to be present at Indiana Grand Casino ("Indiana Grand"). At that time, John Doe #105 had won \$3,515.21 in cash equivalents from Indiana Grand. Indiana Grand withheld the monies as required by Commission regulations. Commission staff seeks approval for remittance to the Commission of the winnings, less applicable taxes, in fulfillment of John Doe #105's voluntary exclusion application.

The Commission, after reviewing this matter:

## **APPROVES**

the remittance of \$3,515.21 less applicable taxes, in fulfillment of John Doe #105's voluntary exclusion application.

Pursuant to IC 4-21.5-3-5, this ORDER becomes effective 15 days following receipt of the Order of the Indiana Gaming Commission.
