

**RESOLUTION 2012-208**  
**A RESOLUTION ADOPTING LSA DOCUMENT #12-55 AS A FINAL RULE**

The Indiana Gaming Commission (“Commission”) adopts the following resolution pursuant to the authority granted to it under IC 4-33-4 and IC 4-35-4.

The Commission has considered the following factors:

1. The Commission began promulgation of the attached LSA Rule Document #12-55 under IC 4-22. A Notice of Intent to adopt LSA Rule Document #12-55 was posted at DIN: 20120201-IR-068120055NIA on the *Indiana Register* website on February 1, 2012. The *Indiana Register* posted the proposed rule at DIN: 20120718-IR-068120055PRA on the *Indiana Register* website on July 18, 2012.
2. The Commission held a public hearing for this rule on September 6, 2012 at 10 a.m. in the offices of the Indiana Gaming Commission, Indianapolis, Indiana, in compliance with IC 4-22. There were no attendees and no public comments at the public hearing. The Commission did not receive any public written comments. All comments received by the IEDC and the fiscal impact statements have all been made available to the Commission. The Commission has also considered the transcript from the public hearing.
3. Following the adoption of the attached rule document as a final rule, the final rule will be forwarded to the Office of the Attorney General and the Governor for approval, and filed thereafter with the *Indiana Register*. The rule will be effective 30 days after it is filed with the *Indiana Register*.

**NOW, THEREFORE, BE IT RESOLVED BY THE INDIANA GAMING COMMISSION,  
THAT THE FOLLOWING RESOLUTION IS ADOPTED:**

**SECTION 1: SCOPE**

This resolution applies to all persons subject to the authority granted to the Commission by the General Assembly in Indiana Code 4-33 and Indiana Code 4-35.

**SECTION 2: DEFINITIONS**

The definitions set forth in IC 4-33, IC 4-35, and 68 IAC apply to this resolution.

**SECTION 3: ADOPTION OF FINAL RULES**

The Commission adopts the following rules as reflected on the attached final rule document:

**68 IAC 1-3-1; 68 IAC 1-3-2; 68 IAC 1-3-4; 68 IAC 1-3-5; 68 IAC 1-3-6.**

Pursuant to IC 4-22-2, the Commission adopts the attached final rule document. Commission staff will forward the rule to the Office of the Attorney General for approval as to legality under IC 4-22-2-32. Upon approval by the Office of the Attorney General, the rule will be submitted to the Governor’s Office for approval pursuant to IC 4-22-2-33. After the rule has been approved or deemed approved

by the Governor, the rule will be submitted to the *Indiana Register* for filing in accordance with IC 4-22-2-35.

**SECTION 4: EFFECTIVE DATE**

This resolution is effective immediately.
