

RESOLUTION 2013-122
A RESOLUTION ADOPTING LSA DOCUMENT #12-280 AS A FINAL RULE

The Indiana Gaming Commission (“Commission”) adopts the following resolution pursuant to the authority granted to it under IC 4-32.2-3.

The Commission has considered the following factors:

1. The Commission began promulgation of the attached LSA Rule Document #12-280 under IC 4-22. A Notice of Intent to adopt LSA Rule Document #12-280 was posted at DIN: 20120530-IR-068120280NIA on the *Indiana Register* website on May 30, 2012. An Administrative Rules Oversight Committee Notice was posted at DIN: 20130206-IR-068120280ARA on the *Indiana Register* website on February 6, 2013. The Indiana Register posted the proposed rule at DIN: 20130501-IR-068120280PRA on the *Indiana Register* website on May 1, 2013.
2. The Commission held a public hearing for this rule on June 3, 2013, at 10 a.m. in the offices of the Indiana Gaming Commission, Indianapolis, Indiana, in compliance with IC 4-22. There were no attendees and no public comments at the public hearing. The Commission received and considered two public written comments. Based on the written comments, the Commission made one change to the proposed rule. All comments received by the IEDC, the change list, and the fiscal impact statements have all been made available to the Commission. The Commission has also considered the transcript from the public hearing.
3. Following the adoption of the attached rule document as a final rule, the final rule will be forwarded to the Office of the Attorney General and the Governor for approval, and filed thereafter with the *Indiana Register*. The rule will be effective 30 days after it is filed with the *Indiana Register*.

THAT THE FOLLOWING RESOLUTION IS ADOPTED:**

SECTION 1: SCOPE

This resolution applies to all persons subject to the authority granted to the Commission by the General Assembly in Indiana Code 4-32.2.

SECTION 2: DEFINITIONS

The definitions set forth in IC 4-32.2 and 68 IAC apply to this resolution.

SECTION 3: ADOPTION OF FINAL RULES



This resolution is effective immediately.


